Criteria:

- A candidate must be a resident of Hunterdon County or Somerset County, who demonstrates a
 dedication to a career in law and a commitment to the values of the law and an ethic of justice,
 fairness and integrity, in the community at large and/or at RVCC. Preference is given to a Hunterdon
 County resident.
- A candidate **must plan to enroll** or **be enrolled** as a student at RVCC and must demonstrate financial need and academic merit. When enrolled as a student at RVCC, the recipient must earn and maintain a GPA of 3.0 or better.
- Amount per Year: \$5,000 (for 30 credits) shall be made in two equal installments for the fall and spring semester. If the candidate is planning to attend classes part-time, the financial award will be pro-rated based on the number of credits a student is taking.
