MINUTES

I. <u>Call to Order</u>

The Regular Meeting of the Board of Trustees of Raritan Valley Community College was held on Tuesday, May 17, 2022 via Zoom Webinar. Chair Caren Bateman called the Regular Board of Trustees meeting to order at 5:00 p.m., and made the following statement in compliance with the Open Public Meetings Act of the State of New Jersey:

"Adequate notice of this meeting has been given in accordance with the <u>Open Public Meetings Act</u> of the State of New Jersey."

II. <u>Roll Call of Members</u>

The roll call was taken as follows:

A quorum was present.

III. <u>Agenda Items</u>

1. President's Report

President Michael McDonough reported that the Commissioners from Somerset and Hunterdon Counties approved three resolutions regarding RVCC's FY23 budget at the Board of School Estimate meeting held earlier in the day. First, they approved the operating allocation for FY23:

Second, they approved the County support for our Supporting Our Children's Future Bond Act application. If approved, the total award to RVCC will be \$5,333,000; the County

support will amount to \$1,333,000. And third, they approved our application for Chapter 12 funding. Our FY23 allocation will be \$3,933,000, with County bond support totaling \$1,966,500. All votes were unanimous, each resolution passing with a vote of 6-0. (For two years in a row, the vote has reflected unanimous support of the College and of its budgeting process.)

The President indicated that our improved process with the Commissioners reflects the Board's insistence on a transparent and collaborative process that balances the complexities of the institutional budget – tuition and fees, county and state support, and other revenue streams.

On behalf of the Board of Trustees and the College community, the President expressed his congratulations to Professor Maria DeFilippis on her well-deserved honor of Professor Emeritus. The Board's action to designate Profess DeFilippis as Professor Emeritus is a fitting recognition of her years of dedication to the students of Raritan Valley Community College. The President remarked that we celebrate Professor DeFilippis's leadership over the years as evidenced by her consistent success with the students and by her contributions to both the College and the community.

2. Approval of Meeting Minutes

The Special and Regular Meeting minutes of April 26, 2022 were moved by Trustee Sullivan, and seconded by Trustee Von Schilling, and approved unanimously by voice vote.

3. Executive Session

Chair Bateman then announced that in accordance with the provision of the Open Public Meetings Act of the States of New Jersey, she would hereby entertain a motion to close the public meeting for the purpose if discussing a personnel issue and the President's Eighth Amendment to his contract. No formal action would be taken during Executive Session and any action taken by the Board would be held public session. The Chair further announced that the Regular Meeting public session would reopen in approximately 45 minutes. On motion by Trustee Swanicke, seconded by Trustee Hirsch, the Board entered into Executive Session.

The Regular meeting reopened to public session at 5:45 p.m.

4. Committee Reports

A. Audit Committee

Chair Caren Bateman reported that the Committee met last month to review the Foundation Audit Report for the Years Ended June 30, 2021 and 2020 and that all was found to be in order.

CONTRACTING UNIT

The Lead Agency shall be responsible for complying with the provisions of the *Local Public Contracts Law* (*N.J.S.A. 40A:11-1 et seq.*) and all other provisions of the revised statutes of the State of New Jersey.

EFFECTIVE DATE

This resolution shall take effect immediately upon passage.

C. Governance, Policy, and President Evaluation Committee

Trustee Paul Hirsch reported that the Campus Safety Report for the period April 19, 2022 to May 11, 2022 was discussed by the Committee and was provided to the full Board of Trustees via SharePoint.

The Board met in Executive Session to discuss the President's eighth amendment to his contract, which followed last's month excellent annual evaluation that was uniformly enthusiastic and positive and met and exceeded the Board's high expectations.

Following discussion, the Committee unanimously recommended to the full Board of Trustees that the following revisions and/or amendments be made to the Employment Agreement with President Michael J. McDonough, Ph.D. dated April 22, 2014 (Resolution #262-2022):

1. TERM OF EMPLOYMENT

- (a) The term of the PRESIDENT's employment under this Agreement shall be extended and continue unless sooner terminated, from June 1, 2022 through and including May 31, 2028.
- 2. COMPENSATION

(a) The PRESIDENT's salary for the period June 1, 2022 to May 31, 2023 shall be \$285,000.

(b) The PRESIDENT's housing allowance shall be increased commencing June 1, 2022 by \$100 per month.

(c) The PRESIDENT's annual employer contribution to the President's 403(b) account shall be increased commencing June 1, 2022 by \$5,000.

(d) The PRESIDENT shall receive a one-time performance award of \$15,000 on June 1, 2022.

Resolution #262-2022 was moved by Trustee Hirsch, seconded by Chair Bateman, and approved unanimously by voice vote.

The President's Expense Report for the period January 1, 2022 through March 31, 2022, reflecting minimal expenses, was reviewed and approved by the Committee.

In conformity with the State of New Jersey statute N.J.S.A. 19:44A-20.4 et seq) with respect to professional services conducted in a fair and open process, Requests for Legal Services for Fiscal Years 2022-2024 was posted in the College's Website on April 11, 2022 (under Current Bidding Opportunities.) The expected response date was May 9, 2022. The Committee discussed our process for selection of Legal Counsel, which has followed, and will continue to follow, the same general procedure and time-lines as in the past.

The process for the Auditor Request for Proposals to provide auditing services for the fiscal years ending June 30, 2022 and 2023 has begun. This invitation is made in conformity with the State of New Jersey's Pay-to-Play statute (N.J.S.A. 19:44A-20.4 et seq.) with respect to professional services conducted in a fair and open process. All proposals are due by Wednesday, May 25, 2022. The Audit Committee will review proposals and the Governance Committee will be updated on the process.

The Committee was also provided updates on a personnel issue, the on-going Middle States process, the Provost/Vice President for Academic Affairs position search, on a

proposed training program for clean room technicians and other potential partnerships to expand on the program in a larger capacity, on the possible future vision for the Tulipwood property in Franklin Township to better serve students and residents of the township, on the Board of School Estimate meeting held earlier in the day, and on an Educational Trustee workshop scheduled early in the fall.

V. <u>Old/New Business</u>

There was no old/new business at the time.

VI <u>Public Questions/Comments</u>

Chair Bateman read the following statement into record:

"The Board will take any comments from the public at this time. The Board will not respond to comments made and speakers are limited to two minutes."

Maria DeFilippis expressed her appreciation to President McDonough and to the Board of Trustees for granting her the distinguished title of Professor Emeritus.

Sara Banfield, co-advisor of RVCC's PTK, highlighted the many accomplishments of the chapter. The RVCC chapter of Phi Theta Kappa was recognized at the Middle States Regional Convention and the International Convention, winning multiple awards.
