## What you need to submit with this form

- 1. **Your statement**: On a separate sheet of paper, you must write a letter that details your special circumstances. You will need to answer the following questions and provide any additional information that you believe to be important to your situation.
  - a. Explain what unusual circumstances should make you an independent student.
  - b. Identify, if known, the location of **BOTH** of your parents. Why are you not able to obtain your parent(s) information for the FAFSA?
  - c. What kind of contact you have with each of them. Include the date of the last time you had contact with them.
  - d. When did you last live with your parent(s)? Did they claim you as an exemption on their tax return this year?
  - e. Describe how you support yourself financially without your parents help? Do your parents provide any financial support such as cash, health insurance, room and board, etc.?
  - f. Where and with whom are you currently living?
  - g. Does anyone have legal custody or guardianship of you? Please submit court documents.

## 2. Documents to Verify you are Independent

Please be aware that <u>ALL</u> Dependency Appeals will not be reviewed without supporting documentation. <u>You must submit letters from parties who have detailed knowledge of your situation.</u> At least one letter must be on official letterhead and signed from a neutral third party/community member (i.e. high school guidance counselor, minister, etc). This person should not be a friend or family member. It should be someone who is aware of the situation, but not involved in it. Attach anything you feel will be relevant, such as court documents.
