RARITAN VALLEY COMMUNITY COLLEGE BOARD OF TRUSTEES' REGULAR MEETING MARCH 7, 2023

MINUTES

I. <u>Call to Order</u>

The Regular Meeting of the Board of Trustees of Raritan Valley Community College was held on Tuesday, March 7, 2023, in-person and via Zoom Webinar. Chair Caren Bateman called the Regular Board of Trustees meeting to order at 5:00 p.m., and made the following statement in compliance with the Open Public Meetings Act of the State of New Jersey:

"Adequate notice of this meeting has been given in accordance with the <u>Open Public Meetings Act</u> of the State of New Jersey."

II. <u>Roll Call of Members</u>

Also in attendance: Michael J. McDonough, President; and Richard Flaum, Esq., College Counsel; and members of the College community.

A quorum was present.

On behalf of the RVCC Foundation Board of Directors, Michael Marion (Executive Director of the RVCC Foundation) invited the Board of Trustees to join the Foundation Board in supporting RVCC Giving Day 2023. Giving Day is a once-a-year, 24-hour online fundraising event in support of the College. Mr. Marion reported that this year's effort will leverage a generous \$50,000 "match challenge." Chair Caren Bateman encouraged trustees to make a gift of any size as we are hoping for full participation from our Board.

III. <u>Agenda Items</u>

1. Approval of Meeting Minutes

The Regular Meeting minutes of January 24, 2023 were moved by Trustee Sullivan, seconded by Trustee Von Schilling, and approved by voice vote.

2. President's/Chair's Report

The President reported that Spring enrollment proved much stronger than we had forecast. The College had budgeted for an annual increase of 2%, but official spring results returned an increase of 8.9% in credit hours (5.8% over spring 2022 in headcount). Here are some of the details associated with this somewhat surprising and stronger than expected enrollment:

•56.8% of increase in new, first-time students. Important because it may suggest that students are beginning to recover from any pandemic-related distress and beginning to return to postsecondary education. More importantly, however, it reflects the idea that students are being very intentional in their choice – that they are selecting the community college as the explicit choice for beginning their postsecondary pathway. If both these trends are accurate and sustained, then it bodes well for future enrollment;

•14.6% of the increase reflects full-time enrollment. This is encouraging and a potential trend that we will need to exploit. Over the past decade, we have seen a steady decline in full-time enrollment, and that decline has had a significant impact on both our tuition and fee revenue and the relationship between operating costs (student supports) and enrollment;

•13.8% increase in male student enrollment. For several years, the US has seen a dramatic decrease in male enrollment at the postsecondary level, so any increase is encouraging;

•12.6% in Latinx students. One of the sharpest demographic trends at RVCC in recent years has been the steady increase in our Latinx population, making RVCC federally recognized as a "Hispanic Serving Institution;"

•6.1% of the increase reflects Somerset County resident and 4.2% increase in Hunterdon County residents;

•Spring dual enrollment reflects an 8.4% increase in headcount (7.7% in credit hours);

•Liberal Arts, Computer Science, and Information Technology saw the biggest enrollment increases.

President McDonough announced that a resolution to honor Trustee Paul Hirsch's service to the Board of Trustees will be on the March 28, 2023 Board of Trustees Regular meeting agenda. The resolution will grant Trustee Hirsch trustee emeritus status and further approve the renaming of the Community Room (located in the Events Conference Center) to The Trustee Paul J. Hirsch Board Room to acknowledge the profound role he has as played at the College for over thirty-six years.

Chair Caren Bateman noted that Dr. Paul Hirsch will be in attendance at the March 28th Board of Trustees meeting and encouraged board members to attend the Board meeting inperson, if possible.

3. Committee Reports

A. Labor Relations Committee

Chair Caren Bateman reported that the Labor Relations Committee met earlier in the day and that negotiations are progressing. The Chair commented that the Board looks forward to success within the next few months. The Committee will continue to update the full Board at future meetings.

B. Finance Committee

Trustee Roger Locandro reported on the Treasurer's Report (Resolution #91-FY23) for the period 01/01/23 to 01/31/23. On motion by Trustee Locandro, seconded by Trustee Shain, the Treasurer's Report was approved by voice vote.

Trustee Roger Locandro then presented Consent Agenda Resolutions #92-FY23 through #102-FY23 and Resolutions #104-FY23 through #106-FY23. <u>Resolution #96-FY23 Replacement of the Hunterdon Hall Transformer (REVISED – Price Increase)</u>

Resolution #103-FY23 Amendment of Perkins V Grant

Professor of Dance Loretta Fois reported that fifteen Raritan Valley Community College Dance majors and three faculty members participated in the American College Dance Conference, held March 1-5 at Montclair State University. The conference's primary focus is to support and promote the wealth of talent and creativity that is prominent throughout college and university dance departments. The conference provides a means for dance programs to perform outside their

own academic setting and to gain exposure to the diversity of college dance throughout the United States.

Colleges present two works for adjudication, and the conference culminates with a gala concert of 10-12 pieces selected for their exemplary artistic quality.

RVCC dance major Cedric Thomas' piece, titled "Call me, Simone," was chosen for the gala. His work also is an alternate for the National College Dance concert in May. This is the third year that RVCC dance artists have been chosen to perform at the gala.
