I. Call to Order

The Regular Meeting of the Board of Trustees of Raritan Valley Community College was held on Tuesday, March 28, 2023, in-person and via Zoom Webinar. Chair Caren Bateman called the Regular Board of Trustees meeting to order at 4:30 p.m., and made the following statement in compliance with the Open Public Meetings Act of the State of New Jersey:

President Michael McDonough then read the following resolution:

Resolution #111-FY23 Tribute for Dr. Paul J. Hirsch

WHEREAS, Dr. Paul J. Hirsch has been a member of the Raritan Valley Community College Board of Trustees since 1986; and

WHEREAS, Trustee Hirsch served with exemplary distinction as Chair of the Raritan Valley Community Board of Trustees from November 2008 to November 2011 and again from November 2013 to November 2015; and

WHEREAS, during Trustee Hirsch's long and distinguished tenure his leadership helped establish

Raritan Valley Community College as one of the most accomplished and innovative community colleges in both the state and the nation; and

WHEREAS, Trustee Hirsch's impressive record of achievement includes the transformation of the entire campus from the opening of The Edward Nash Theatre to the dedication of the Evelyn S. Field Library to the creation of the RVCC Event Center to the founding of the Ray Bateman Center for Student Life and Leadership to the establishment of a state-of-the-art workforce training center and to the expansion of the Christine Todd Whitman Science Center; and

WHEREAS, Trustee Hirsch established and so generously supports The Morris and Dorothy Hirsch Research Library of The Holocaust, Genocide, and Racism; and

WHEREAS, Trustee Hirsch has guided the institution through multiple strategic plans, has helped the college realize record student enrollment, and has led the college through the complex process of accreditation; and

WHEREAS, Trustee Hirsch has nurtured a culture of Board governance that meets the highest demands of shared governance, of fiduciary responsibility, and of integrity and independence; and

WHEREAS, Trustee Hirsch has made profound contributions to the College's fiscal strength and has championed transparency and accountability; and

WHEREAS, Trustee Hirsch has been instrumental in selecting RVCC's current president and many former presidents; and

WHEREAS, Trustee Hirsch has focused his long, distinguished, and devoted service on several key areas: he has been an eloquent and passionate advocate for all students; he has championed the highest ideals and practices of Board governance; and he has been the quiet and steady presence behind a campus culture that embraces diversity, that encourages civic engagement, that supports meaningful Service Learning, that promotes environmental stewardship, and that strives for excellence in all endeavors; and

WHEREAS, Trustee Hirsch's leadership has helped create a Board and a college community that reflects his own values and his own character – an unwavering commitment to independence, to integrity, to care, to loyalty, and, above all, to a generous, inclusive, engaged, compassionate, and humane citizenship;

Now, THEREFORE, BE IT RESOLVED, that the RVCC Board of Trustees, Secretary to the Board Sheri Pontarollo, President Michael J. McDonough, and all members of the College community wish to express their deepest gratitude and appreciation to Dr. Paul J. Hirsch for his profound contributions to RVCC; to bestow upon him the title of *Trustee Emeritus* for his outstanding leadership; and to rename RVCC's Community Room **The Dr. Paul J. Hirsch Board Room**.

Following a standing ovation, Chair Bateman, President McDonough, members of the Board of Trustees, members of Bateman family, and the audience praised Trustee Emeritus Hirsch for his years of dedication and service to the College and extended their deepest gratitude and appreciation.

Chair Caren Bateman commented, with a tear in her eye, that she must also say good-by and a heartfelt thank you to a man who has dedicated nearly 4 decades of his life to the success of

Raritan Valley Community College. Paul Hirsch has used all the resources at his disposal, a keen intellect, sound judgement, a historical perspective, a gentle personality, an amazing vision for the future of this College, and a calm voice to all discussions, even the challenging ones. He mentored most of us and made us understand good governance and our fiduciary roles as Trustees, always keeping the College's mission in our view. Dr. Paul has been involved in nearly all the significant decisions during his 36-year tenure that resulted in RVCC becoming a state, regional, and nationally recognized institution. His knowledge of the economic needs of the bicounty area has driven RVCC's role in providing a well-educated work force to fuel our local economy. Dr. Hirsch also serveD on the RVCC Foundation Board and was a driving force in the creation and completion of the Holocaust & Genocide Library. He has served on Presidential Selection Committees, and helped select our current President. He has been involved in most of the infrastructure changes to the College and in formulating the direction we move in today. There is so much more, but for now, we thank him and the College will miss him.

President McDonough began his remarks by noting that he got the opportunity to be the president of RVCC because of Dr. Hirsch. And whatever success we have enjoyed as an institution is because of Paul's unwavering support and thoughtful guidance. He said that his tenure has lasted this long because of Paul and because of his generosity and his thousands of small kindnesses. He added that Paul represents the very best of that unique American invention – the community college. Paul is committed to access, to opportunity, to that most American of all values – the second chance. Paul is a quiet but determined advocate for all our students. He is, above all, engaged, innovative, and humane. He is RVCC's accomplished community citizen – a champion of this great college.

President McDonough also took the opportunity to thank Sheri Pontarollo. Alongside Paul, Sheri has forged a college and a board in her own character: Sheri treats every single person who comes on campus with care, with kindness, and with compassion. He paused and said that is how Sheri has treated him since the very first day he set foot on campus.

He concluded his remarks by thanking Sheri and Paul, adding that he owed them both a debt he can never repay. You have been the stewards of this college for over 35 years and you deserve our thunderous applause and our most sincere thanks.

President McDonough ended his brief remarks by quoting a favorite Shakespearian couplet, a passage that so perfectly describes his feelings for Sheri and for Paul:

I count myself in nothing else so happy As in a soul remembering my good friends.

Trustee Emeritus Paul Hirsch expressed his gratitude to President McDonough, the Board of Trustees, to the Bateman family, and members of the College community.

III. Agenda Items

1. Approval of Meeting Minutes

2. President's/Chair's Report

Chair Bateman reported that Raritan Valley Community College had a record-setting "Giving Day" on March 23 and raised \$163,830 for student clubs and athletic teams, as well as a range of centers, institutes and critical institutional programs. The Chair expressed her appreciation to the Board of Trustees for their participation.

The Chair announced that the President's annual evaluation Survey Monkey instrument, along with his self-evaluation, will be sent to the full Board in the near future and the final results of the evaluation will be made available to the President and the full Board at the May 2nd Board meeting. In addition, the Governance Committee will review the President's annual amendment to his contract and will provide a recommendation to the full Board at the May 2, 2023 Regular Board meeting.

3. Committee Reports

A. Audit Committee

Chair Caren Bateman reported that the Audit Committee met earlier in the day to review the College's annual audit and indicated that it was a clean report.

WHEREAS, the high voltage electrical distribution system that serves a portion of the campus failed early in the morning of Monday, February 20, causing a campus-wide power outage; and

WHEREAS, after extensive examination and testing by a third-party specialty electric services

company – MetroTek--it was determined that two sections connected to the West and Science buildings had shorted requiring replacement of approximately 650 linear feet of 3-phase cables; and

WHEREAS, because time was of the essence to insure continuity of instruction and other campus operations, MetroTek was authorized to purchase the required replacement cabling and connectors and have their repair crews work as expeditiously as possible, including overtime related to the holiday (Presidents' day) and into the evening of a second day; and

WHEREAS, in accordance with N.J.S.A. 18A: 64A-25.6, any purchase, contract, or agreement may be made, negotiated, or awarded by a county college without public advertising for bids, when an emergency affecting the health, safety, or welfare of occupants of college property requires the immediate delivery of the materials, or supplies, or the performance of the work required to rectify such conditions.
