

**Program Articulation Agreement
Between
Millersville University of Pennsylvania and Raritan Valley Community College**

This Program Articulation Agreement is between:

Bachelor of Science in Business
Millersville University of Pennsylvania
(Millersville, PA)

and

Associate of Science in Business
Raritan Valley Community College

Millersville University of Pennsylvania, hereafter referred to as MU, and Raritan Valley Community College, hereafter referred to as RVCC, set forth the conditions upon which Millersville University will consider graduates of the Associate of Science in Business at RVCC to transfer for admission into the Bachelor of Science in Business at MU.

A. Rationale for the Purpose of the Articulation Agreement

This agreement applies only to students completing the Associate of Science in Business at RVCC and wishing to articulate to the Bachelor of Science in Business at MU.

B. Admissions Requirements and Transfer of Academic Credit

- 1) Students enrolled in the Associate of Science in Business at RVCC who wish to articulate to the Bachelor of Science in Business at MU must complete the Millersville University admission process, including but not limited to: Millersville University admissions application, application fee, and submission of all official transcripts from secondary and post-secondary institutions.
- 2) Millersville University agrees that graduates of the Associate of Science in Business meet the admissions standards of the Bachelor of Science in Business at MU if they satisfy the following conditions:
 - a. Applicants with at least a 2.0 grade point average (GPA) at RVCC are eligible for admission to Millersville University.
 - b. Prior to matriculation to Millersville University, the student will have successfully completed the Associate of Science in Business at RVCC and will have forwarded final, official transcripts indicating the award of Associate of Science in Business at RVCC to Millersville University.
- 3) Millersville University agrees that graduates of the Associate of Science in Business at RVCC will be able to transfer courses and credits to Millersville University towards the Bachelor of Science in Business as follows:
 - a. Coursework completed at RVCC with a grade of "C" or better will be eligible to be considered for transfer to Millersville University.


- b. Coursework completed at RVCC towards satisfaction of the requirements for the Associate of Science in Business will transfer to Millersville University as outlined in Appendix A of this agreement
- c. Coursework completed at RVCC beyond those outlined in Appendix A may be considered for transfer to Millersville University.

C. Renewal or Termination of Articulation Agreement:

- 1) RVCC agrees to promptly notify Millersville University of any substantive curricular modifications to the Associate of Science in Business program and further agrees that the terms of this agreement will no longer hold unless Millersville University provides a written approval that the curricular changes do not alter the intent of the agreement.
- 2) Millersville University agrees to provide RVCC with information about the Bachelor of Science in Business at Millersville University and any changes to the curriculum, if they should occur. Conditions for admission in the Bachelor of Science in Business at Millersville University are stipulated in section B of this agreement.
- 3) The terms of the agreement shall remain in effect, except as stipulated in certain previous terms as listed herein, until terminated by either party. Any party may terminate the agreement with or without cause, on the provision of 120 days written notice to the other party.

This agreement is not a legally binding contract and is not enforceable in a court or in the Pennsylvania Board of Claims. In the event of a dispute between the parties, advice and direction will be offered by the Office of the Chancellor of the Pennsylvania State System of Higher Education.
