MINUTES

I. <u>Call to Order</u>

The Regular Meeting of the Board of Trustees of Raritan Valley Community College was held on Tuesday, March 26, 2024, in-person and via Zoom Webinar. Chair Zenon Christodoulou called the Regular Board of Trustees meeting to order at 4:00 p.m., and made the following statement in compliance with the Open Public Meetings Act of the State of New Jersey:

III. <u>Agenda Items</u>

1. Approval of Meeting Minutes

The Regular meeting minutes of February 20, 2024 were moved by Trustee Jinks, seconded by Trustee Sullivan, and approved by voice vote.

2. President/Chair Reports

President McDonough reported that RVCC was one of only ninety-three US campuses that have been recognized for its strong action plans to increase nonpartisan democratic engagement by promoting civic participation and political engagement.

The president then reported that Raritan Valley Community College had another successful "Giving Day" on March 21st. Through the tireless efforts of the RVCC Foundation staff that consists of only two full-time and 1 part-time employees, \$154,355 was raised. The president acknowledged the generosity of students and staff alike. He shared that Giving Day's success reflects the hard work and dedication of the RVCC Foundation to whom he is grateful for.

The president discussed the Governor's proposed FY25 budget. He reported that there will be significant cuts to operational aid. He spoke about the email campaign to swamp the legislature. He implored anyone who is invested in the college to participate in the campaign because numbers matter and emails matter. The president then read a letter from a staff member written to a Senator which conveyed the importance of the community college education.

Chair Zenon Christodoulou recognized everyone celebrating upcoming religious celebrations such as Holy Week, Ramadan, Passover and Orthodox Easter.

- 3. Committee Reports
 - A. Strategy and Vision Committee

Trustee Adam Shain reported that the Committee met earlier in the day where President McDonough presented the 2nd Pillar of the College's Strategic Plan which addresses pedagogical and delivery integrity as well as performance opportunity gaps. Trustee Shain said that the President took the lead in providing a plan that will advance the school long-term.

B. Finance Committee

Trustee Roger Locandro reported on the Treasurer's Report (Resolution #110-FY24) for the period 2/01/24 through 2/29/24. On motion by Trustee Locandro, seconded by Trustee Von Schilling, the Treasurer's Report was approved by voice vote.

<u>Title</u>: PSE&G Energy Efficiency Grant

WHEREAS, Much of Raritan Valley Community College's campus mechanical system infrastructure - HVAC and electrical distribution -is quite old and represents a significant portion of its deferred maintenance backlog; and

WHEREAS, the College has been replacing infrastructure components on a gradual basis as funding permits determined by analysis of realistic useful lives (beyond manufacturer estimates) and equipment failure; and

WHEREAS, PSE&G is offering an Engineered Solutions Energy Solutions Program (ESESP) backed by the state of New Jersey which provides funding to address a significant portion of this infrastructure; and

WHEREAS, PSE&G's consulting engineers have identified approximately \$6.7 million of project costs affecting most campus buildings which are estimated to generate annual utility savings (gas and electric) in excess of \$570,000; and

WHEREAS, the PSE&G program would provide 52% of the total cost, or \$3.5 million, and require the College to pay back the remainder of \$3.2 million over 5 years without any interest accruing; and

WHEREAS, College Management believes that the annual utility savings and reductions of maintenance and repairs to much older equipment would offset the College's share of project costs and provide longer-term benefits with annual operating budget savings and lower capital replacement needs.
