- ☐ **I understand that, if admitted, continuation in the Clinical MLT Program is contingent on the submission of mandatory health and safety requirements by July 15 of the current year. I will be removed from the program if I fail to submit each of the following requirements by the deadline. Detailed instructions for submission of all health and safety records to SentryMD will be provide upon acceptance into the program.**
 - A clean criminal background check completed through Adam Safeguard. Please note that it can take 30+ days for the background check to be completed. The process should be started immediately upon acceptance into the Clinical MLT Program. Detailed instructions will be provided upon acceptance into the program.
 - A negative drug screen completed between June 1st and August 20th of the current year.
 - Color Vision Test
 - Proof of the following immunizations/titers. If the lab test shows low titers, proof of a booster dose must be submitted by the deadline.
 - Completed vaccine series or positive titer for measles, mumps, and rubella (MMR)
 - Completed varicella (chicken pox) vaccine series, positive titer, or a documented case of chickenpox
 - Completed vaccine series or positive titer for hepatitis B
 - Tetanus (Tdap or Td) booster within the past ten years
 - Influenza vaccine for the current flu season
 - Negative Tuberculosis skin test or blood draw; if positive, chest x-ray required
 - Completed COVID-19 vaccine series
- ☐ **I understand that the following criteria will be used to rank applicants for the MLT Clinical Program. When the number of applicants exceeds the number of available seats, admission will be granted to the students with the most points.**
 - Up to twelve (10) points will be awarded for academic performance in science and math prerequisites (BIOL, CHEM, MATH, MLTC). One (1) point will be awarded for each 'B' grade, and two (2) points will be awarded for each 'A' grade.
 - Up to 10 points will be awarded based on the TEAS test score. See the link here for registration and exam information. Choose "Allied Health" as a category when registering for the exam. <https://www.atitesting.com/teas/register>

- Ten (10) points will be awarded to applicants with prior healthcare employment experience. A letter from your employer on company letterhead confirming employment must be attached.
- Five (5) points will be awarded to applicants with prior healthcare volunteer experience. A letter from your supervisor on company letterhead confirming employment must be attached.
- Honorably Discharged Military Veterans or will be awarded two (2) additional points. Proof of honorable discharge must be attached.
- Applicants with a Bachelor's degree by the application deadline will be awarded two (2) additional points. An unofficial transcript from the degree-granting institution must be attached.
- Applicants who have completed MLTC 100 with a "B" or better by the application deadline will be awarded one (1) additional quality point.
- I understand that for my application to be considered complete, I need to submit the degree audit and other supporting documents such as proof of healthcare employment/volunteering work, proof of honorable discharge, proof of bachelor's degree to this address mlt@raritanval.edu
