

WITHDRAWAL & REFUND SCHEDULE FOR FALL 2026

Students may withdraw from courses through the Lion's Den (requires an RVCC Student ID Number and password) through the end of the specified withdrawal period. Students may also withdraw from courses by using the Add/Drop form available in the Student Enrollment Center or online [Student Profile](#) go to Your Student Profile → EduNav (Add/Drop Courses); follow instructions on the Add/Drop form. The form may be submitted in person during regular business hours or faxed to the Student Enrollment Center at (908) 704-3442.

Students are not permitted to withdraw from Developmental Studies courses while maintaining registration in college-level courses. Exceptions may be granted only by consultation with an Academic Advisor or Counselor.

The amount of your refund depends on the date your drop/add form or online transaction is submitted to the Student Enrollment Center. Refunds are calculated at a rate less than 100% after the completion of the first five business days of the full term, or after the completion of a corresponding prorated period for other sessions or special late-starting modules or courses, as listed below.

April 6, 2026	In-person, mail and web registration for all students.
April 15, 2026	Financial Aid deadline for renewal students who have received state aid in the past.
August 12, 2026	Fall 2026 Tuition bills are due or payment plans must be submitted. After this date, bills are due at time of registration.
September 2, 2026	\$50 late registration fee begins for Full Term, RISE 14-Week Session, First 7-Week Session and First 3½-Week Session.
September 2, 2026	Fall semester Full Term, RISE 14-Week Session, <u>First</u> 7-Week Session & First 3½-Week Session classes begin.
September 16, 2026	\$50 late registration fee begins for 12-Week Session.
