MINUTES

I. Call to Order

The Regular Meeting of the Board of Trustees of Raritan Valley Community College was held on Tuesday, September 19, 2017, at Raritan Valley Community College, Route 28 and Lamington Road, Branchburg Township, North Branch, New Jersey.

Swearing-in New Board of Trustees Member – Edward Malley

At that time, Philip Stern, College Counsel, swore-in new Board of Trustees alumni representative Edward Malley. Mr. Malley, a resident of Hillsborough, graduated from RVCC in May and is continuing his education this fall at the Edward J. Bloustein School of Planning and Public Policy at Rutgers University, New Brunswick. Edward plans to study public policy, focusing on public management. In addition, Mr. Malley has officially enlisted with the New Jersey National Guard as a PFC (Private First Class) and has enrolled as a cadet in the Rutgers ROTC classes this fall. Mr. Malley indicated that he is honored to become a member of the RVCC Board of Trustees and that he looks forward to working with the President and the Board. On behalf of the Board of Trustees and the President, Chairman Wise welcomed Mr. Malley and congratulated him on his appointment to the RVCC Board of Trustees by the student-body.

III. Agenda Items

1. Approval of Regular Meeting Minutes

The Regular Meeting minutes of August 29, 2017 were approved by voice vote. Trustee Windrem and Chairman Wise respectfully abstained.

2. Chairman's Report

Chairman Robert Wise reported that the Foundation's 2nd Annual Giving Day is scheduled for Thursday, November 16th, 2017. It was reported that last year the Foundation raised over \$15,000 from over 300 donors for RVCC's clubs and organizations and the goal this year is to connect to 500 donors and inspire them to make a donation to benefit RVCC students and faculty. (More information will be provided at the October meeting.)

The Chairman reminded Board members that the Regular Board of Trustees meeting and Reorganization meeting are scheduled for Tuesday, December 5, 2017. In addition, Chairman Wise reported that the Board Audit Committee will hold a special meeting on Tuesday, November 21, 2017 from 3 to 4:30 p.m. and noted that no other committees will meet on that date.

The Chairman further asked the Board to hold October 25th, 2017 for the College's 50th Anniversary Gala.

3. President's Report

President Michael McDonough gave a warm welcome to new Board of Trustees alumni representative Edward Malley.

The President reported that Dr. Lawrence Nespoli, President of the New Jersey Council of County College, announced that he is retiring from the Council in January 2018. The President, on behalf of the Board of Trustees and College community, acknowledged Dr. Nespoli's twenty-seven years of service to the New Jersey community college sector.

In light of some issues surrounding another NJ community college, the President expressed his gratitude to the RVCC Board of Trustees for being a great governing board that continues to recognize the importance of their role and the difference between oversight and operational while preserving the autonomy from political influence.

The President congratulated Janet Dunne, the College Foundation's fundraising coordinator, on being selected to participate in Leadership Hunterdon, a nine-month program sponsored by the Hunterdon County Chamber of Commerce Foundation that is designed to prepare citizens for civic leadership through education and exploration of issues affecting our community.

In addition, the President reported that Catherine Hebson McVicker, former trustee and current Foundation Board of Directors member, was presented with the Ronald D. Winthers Community College Trustee Leadership Award for her dedicated service to New Jersey's 19 community colleges on June 19, 2017. This award is an honor bestowed on a single New Jersey community college trustee each year to recognize visionary leadership by a New Jersey community college trustee at the local, state and national levels. Catherine joined the Board of Trustees at Raritan Valley Community College in 1986, and chaired the Board from November 2011 to November 2013. The RVCC Foundation has been fortunate to have Catherine as a treasured Foundation Board member since 2002.

Items of Note

ROARS

The ROARS (Raritan's Orientation, Advising and Registration Session) season has concluded for fall 2017 enrollment. Efforts ranged from checking students in, updating records, taking photo IDs, giving tours, presenting, meeting with parents, registering for classes, providing refreshments, setting up and cleaning rooms, providing media, resetting passwords, making phone calls, answering questions, and cheerleading from the sidelines. The numbers below identify students who attended and enrolled at ROARS by month. Over the span of 18 traditional sessions and six added registration sessions, over 1,500 first-time college students started courses this fall semester.

Transfer and Career Services

In keeping with its commitment to expand educational opportunities for its students, Raritan Valley Community College signed two new international transfer agreements during the 2016-2017 school year. The agreements with the University of the West of England and the University of Lincoln join with other international signings in the past few years—including with The American University of Paris and the University of Greenwich—in offering graduates the opportunity to complete their Bachelor's Degree outside of the US.

The agreement with the University of the West of England, Bristol, signed this past winter, enables students who complete their Associate Degree from RVCC to seamlessly transfer to UWE to complete their Baccalaureate Degree.

The partnership with the University of Lincoln in Lincolnshire, which was formalized last fall, enables students who receive an Associate of Arts in Liberal Arts – Social Science Option from RVCC to seamlessly transfer into the level two of the BSc (Hons) Psychology program at Lincoln. RVCC graduates also benefit from a 20 percent discount off tuition for each year of study at the university.

For graduates looking to continue their education a little closer to home, RVCC has partnered with Chestnut Hill College (CHC) in Philadelphia to offer transfer and scholarship opportunities. According to the agreement that was signed in March, RVCC graduates continuing their studies at CHC may be eligible for academic scholarships ranging from \$12,000-\$19,000 for full-time students, depending on their GPA and membership in the Phi Theta Kappa honor society. Discounted tuition, with the amount based on a student's Grade Point Average, is available for part-time students and those attending CHC's School of Continuing & Professional Studies.

Last fall RVCC also signed transfer agreements with Millersville University in Pennsylvania and Rider University in Lawrenceville. The agreement with Rider enables students in 18 different majors to seamlessly transfer to the university to complete their Bachelor's Degree. The agreement, which was signed in September, covers majors that focus on such areas as Biology, Chemistry, Environmental Science, Nursing, Education, Criminal Justice, Exercise Science, Business Administration, English, Communication Studies, Mathematics, Liberal Arts, and Social Science. Students who are members of RVCC's chapter of the Phi Theta Kappa honor society also may be eligible for scholarship aid.

The agreement with Millersville University provides for the seamless transfer of RVCC students who are interested in continuing their studies in the areas of business, communication, and speech communication.

RVCC Students Selected to Participate in NASA Community College Aerospace Scholars Project
Raritan Valley Community College students Kaitlin Rock of Washington Township (Warren County) and
Mark Romero of North Plainfield have been selected to participate in the NASA Community College
Aerospace Scholars (NCAS) project. Rock and Romero, who are both RVCC Engineering Science majors
focusing on Mechanical Engineering, are among a group of 304 community college students from across the
U.S. taking part in NCAS. Their participation began this summer in an online program focusing on such
topics as Mars Rovers, traveling to Mars, NASA research, the effects of space weather, and the changing
climate.

The five-week online scholars program will culminate with a four-day on-site event at Langley Research Center in Hampton, VA, September 25-28. The experience will offer students the opportunity to interact with NASA engineers and others as they learn more about careers in science and engineering. While at NASA, students will form teams and establish fictional companies interested in Mars exploration. Each team is responsible for developing and testing a prototype rover, forming a company infrastructure, managing a budget, and developing communications and outreach. The on-site experience at NASA also includes a tour of facilities and briefings by NASA subject matter experts.

NASA Community College Aerospace Scholars is a project funded in part by the Minority University Research and Education Program, or MUREP, which is committed to engaging underrepresented and underserved students in science, technology, engineering and mathematics (STEM) in authentic learning experiences to sustain a diverse workforce.

Stephen Hudson will be performing at the Somerville Jazz Festival, September 17, 2017 at 3 pm, with the Claire Daly Quintet (Claire Daly-saxophone/flute, Steve Hudson-piano, Jerome Harris-guitar, Marcus McClaurine-bass, and Peter Grant-drums). Hudson also composed music for the short film, *Still Water Runs Deep*, directed and written by Abbesi Akhamie, which will hold its world-premiere at the Toronto International Film Festival this September.

Wes Sherman has curated two exhibitions at The Center for Contemporary Art in Bedminster, NJ – *Last First Dance* new work by Lucas Kelly and *Synthesizing Nature*, co-curated with Cory Card (curator at View Art Center, Old Forge, NY.) This exhibition first showed at The View earlier this year and is now at The Center. It includes RVCC artists Tiffany Calvert, Colin Edgington, and Jonathan Ricci. Both exhibitions will run through November 4, 2017.

Barbara A. Friedman is currently in two group shows presenting recent landscape paintings featuring New Jersey views at Gallery U "The Grass is Greener" in Westfield, NJ and Village West Gallery "NJ and You" in Jersey City, NJ.

Darren McManus has twelve paintings and four drawings in a group exhibition titled "Origins" at Parlor Gallery in Asbury Park, NJ. McManus, along with Jean Pierre Arboleda and Hannah Yata, are the featured artists in this group show focused on artists who work with themes of nature, religion, science, and mythology. The opening reception was Saturday, September 16th from 7 to 11 pm and the exhibition runs from September 16 to October 30, 2017.

The RVCC Art Faculty Exhibition continues in the College Art Gallery until September 22.

Foundation

Tony Cava will be honored as the 2017 Spirit of Somerset Awards Recipient for Health/Wellness on September 27 at the Raritan Valley Country Club. The event will raise funds for Somerset Treatment Services in Somerville. And more good news...this past May, Tony was named President of Robert Wood Johnson University Hospital Somerset. Tony joined the hospital in 2015 as Chief Administrative Officer. During his tenure at RWJUH Somerset, Tony has overseen significant renovations and growth, including renovations to the hospital's cardiac catheterization laboratory, maternity unit and main lobby and opening the state's first primary care services for the LGBTQIA community, a Wound Care Center, and a Walgreen's in the hospital's Emergency Department. The hospital is currently renovating its Behavioral Health Unit and

space for its Vascular Laboratory. Later this year, a three-year cardiology renovation and expansion project and a surgical services department renovation project will begin.

4. Committee Reports

A. Strategic Planning Committee

Trustee Tracy DiFrancesco reported that all Committees reviewed the draft Strategic Plan and that it is the Committee's intention to make a recommendation to approve the new Plan at the October Board of Trustees meeting. Trustee DiFrancesco reported that the Committee was also provided an enrollment update. She congratulated the Enrollment team on all of their efforts enrolling students.

Resolution #146-2017 - Acceptance of Grant Funds for the Mathematics and Science Partnership

WHEREAS, Raritan Valley Community College is committed to partnerships with our community school districts and Universities; and

Resolution #152A-2017 - Natural Gas Forward Purchases

WHEREAS, Raritan Valley Community College consumes a significant amount of natural gas during the year to provide heating and to power its co-gen engine for electricity and most of its central cooling; and

WHEREAS, the College's current contract for raw material and delivery charges expires October 31, 2017 and the College had been advised by its independent consultant New Energy Consultants (NEC) that current market conditions were favorable to a decision to obtain additional forward pricing of natural gas; and

WHEREAS, NEC will assist the College in preparing and distributing an RFP to potential suppliers, the response to which is due back by 11:00 AM on September 28; and

WHEREAS, the bid specifications included a primary component to set the producer's commodity cost and delivery charge for a 12, 24 and 36-month period regardless of the volume of gas purchased; and

WHEREAS, time will be of the essence to make a decision by 3:00 PM on the same day that the bids are due (September 28), and acknowledging that the Board of Trustees will not be able to act in timely fashion; and

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of Raritan Valley Community College authorizes the President or Vice President of Finance & Facilities to enter into a contract and issue purchase orders to the successful bidder. The Board will affirm the contract award at its October 17th meeting.

Trustee Paul Hirsch reported on the following resolution:

Resolution #153-2017 – RVCC Emergency Operations Plan

WHEREAS, New Jersey statutes – A-2405; PL 2011, c.214 -- require each of the state's higher education institutions to formally adopt an Emergency Operations Plan (EOP) every five years beginning in 2012; and

WHEREAS, The Federal Clery Act and the Federal Higher Education Authorization Act all oblige the College to have a plan in place and to regularly test/assess its effectiveness; and

WHEREAS, The College last adopted a plan on June 26, 2012 via resolution #71-2012; and

WHEREAS, Management believes that the new EOP meets all of the various agency objectives, having been revised with significant input from local law enforcement via operational exercises and detailed discussions relating especially to Active Shooter situations.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of Raritan Valley Community College adopts the revised 2017 Emergency Operations Plan.

The resolution was moved by Trustee Hirsch, and seconded by Trustee Hazard. It was reported that New Jersey statute requires formal adoption by the Board of Trustees every five years and that RVCC last adopted a plan on June 26, 2012. It was further reported that management believes that the new Emergency Operation Plan meets all of the various agency objectives, having been revised with significant input from local law enforcement via operational exercises. The Committee will be provided updates on employee training and drills at future meetings.

There being no further comments or questions, the Resolution was unanimously approved by voice vote.

The Committee initiated discussions on new mission and vision statements for the College.

The Committee was provided a draft guideline/code of conduct for campus visitors by College Counsel, which will be discussed in more detail at a future meeting.

The annual Board self-evaluation instrument will be reviewed by the Committee at their October meeting and the Committee hopes to commence the process immediately following its approval, with a short turnaround period. Trustee Margaret Windrem, who has graciously agreed to oversee the process, hopes to provide a full report at the December meeting.

The Committee began initial discussions on the concept to develop a student housing development along vacant college property adjacent to Route 28. The Committee will revisit discussions at a future meeting.

The Committee was provided an update on the College's fall enrollment and also on the national and state trends of declining enrollment.

As required by the State of New Jersey, the Committee reviewed the Campus Safety Report for the period August 29 through September 18, 2017.
