

STUDENT TRANSFER AGREEMENT BETWEEN RARITAN VALLEY COMMUNITY COLLEGE AND SCHOOL OF VISUAL ARTS, INC.

This Student Transfer Agreement (the "Agreement") is made as of June 20, 2010 between Raritan Valley Community College (hereinafter called "RVCC"), a college having its address at 118 Lamington Road, Branchburg, New Jersey 08876 and School of Visual Arts, Inc. (hereinafter called "SVA"), a university having its address at 209 East 23 Street, New York, NY 10010-3994, U.S.A.

WHEREAS

- a) Associates of Fine Arts: Visual Arts degree students at RVCC may seek third year placement in the Bachelor of Fine Arts (BFA) program in Fine Arts at SVA.
- b) Both institutions are agreeable to the establishment of a student transfer agreement contingent upon the following conditions and areas of agreement.

1.0 AREAS OF AGREEMENT

This Agreement is intended to outline a specific course of study for Associates of Fine Arts: Visual Arts degree students at RVCC who may wish to apply to transfer into the third year of the BFA program in Fine Arts at SVA, as follows:

- 1.1 Following the review of the RVCC curriculum, SVA anticipates that RVCC students who successfully complete the course of study for the Associates of Fine Arts: Visual Arts at RVCC, listed on the attached Course Comparison Chart, will be eligible to apply for transfer into the Bachelor of Fine Arts program in Fine Arts at SVA and graduate within two additional years of full-time study.
- 1.2 Students must successfully complete all RVCC courses listed on the attached Course Comparison Chart, which shows course equivalencies between RVCC courses and SVA courses that satisfy BFA degree requirements at SVA.
- 1.3 Transferring students, whose first language is not English, must have a minimum Ibt TOEFL score of 79 (or 6.5 IELTS score). In addition, a cumulative grade point average of 2.5 at RVCC is required. Credits will only be awarded for those courses at RVCC in which students earn a grade of C or better.

- 1.4 Transfer placement of any student is contingent upon satisfactory review and approval by SVA's admissions office and the Fine Art Department chair, in accordance with SVA's admissions process, of the student's application, including without limitation the student's portfolio and transfer credits, and is subject to space availability in the program.
- 1.5 A total of 60 credits may be accepted in transfer as follows: 15 credits in humanities and sciences, 9 credits in art history and 36 credits in studio. Students would then be required to complete 9 credits in art history, 15 credits in humanities and sciences, 36 credits in studio at SVA.

This Agreement is not intended to, and does not, create any binding obligations between the parties under the laws of any country or jurisdiction.

2.0 CONDITIONS

This Agreement:

- 2.1 will come into effect upon the signature by the President of RVCC and the president of SVA;
- 2.2 will apply for a period of five (5) years—June 20, 2010 to June 20, 2015 unless terminated earlier in accordance with 2.3 that follows;
- 2.3 may be terminated by either party giving to the other party no less than three (3) months notice in writing.

3.0 LIMITATION OF LIABILITY, GOVERNING LAW

In no event shall either party have liability to the other, or to any other person or entity, for any reason whatsoever under this Agreement, and neither party shall be entitled to claim any breach or damages by reason of any action taken, or for any failure to take any action, pursuant to this Agreement. This Agreement shall be governed by the substantive laws of the State of New York, USA, without reference to its conflicts or law rules or any other law that might require the application of the substantive laws of any other jurisdiction.
