  - b. Identify, if known, the location of both of your parents and what kind of contact you have with each of them. Include the date of the last time you had contact with them. When did you last live with your parent(s)? Did they claim you as an exemption on their tax return this year?
  - c. Why are you not able to obtain your parents information for the FAFSA?
  - d. Describe how you support yourself financially without your parents help? Do your parents provide any additional support such as cash, health insurance, room and board, etc?
  - e. Where and with whom are you currently living?
  - f. Does anyone have legal custody of you? Please submit court documents.

## 2. Documents to Verify you are Independent

Please be aware that <u>ALL</u> Dependency Appeals will not be reviewed without supporting documentation. <u>You must submit letters from parties who have detailed knowledge of your situation.</u> At least one letter must be on official letterhead and signed from a neutral third party/community member (i.e. high school guidance counselor, minister, etc). This person should not be a friend or family member. It should be someone who is aware of the situation, but not involved in it. Attach anything you feel will be relevant, such as court documents.
