# **MINUTES**

#### I. <u>Call to Order</u>

The Regular Meeting of the Board of Trustees of Raritan Valley Community College was held on Wednesday, August 21, 2019, at Raritan Valley Community College, Route 28 and Lamington Road, Branchburg Township, North Branch, New Jersey.

Chairman Robert P. Wise called the Regular Board of Trustees meeting to order at 5:15 p.m., and made the following statement in compliance with the Open Public Meetings Act of the State of New Jersey:

"Adequate notice of this meeting has been given in accordance with the <u>Open Public Meetings Act</u> of the State of New Jersey."

### III. <u>Agenda Items</u>

1. Approval of Regular Meeting Minutes

On motion by Trustee Hirsch, seconded by Trustee Bateman, the Regular minutes of June 25, 2019 were approved by voice vote. Trustee Torres respectfully abstained.

2. Chairman's Report

Chairman Robert Wise welcomed back the Board of Trustees and entire College community and wished everyone a great fall semester.

3. President's Report

President Michael McDonough reported that the personal-finance website WalletHub recently released 2019's Best & Worst Community Colleges, INCLUDING its state-by-state ranking of the Best & Worst Community-College Systems. To determine where students can receive the best education at the cheapest rates, WalletHub compared 710 community colleges across 19 key indicators of cost and quality. The data set ranges from the cost of in-state tuition and fees to student-faculty ratio to graduation rate. Raritan Valley Community College ranked 20 on the Top 20 Community Colleges nationally and number 1 within the State of New Jersey. (New Jersey ranked number 11 on the states with the best community-college systems.)

President McDonough distributed a copy of his written report, as follows:

### Highlights from President's Messages

•Our new transfer agreement with the Pennsylvania Academy of Fine Arts, will allow RVCC students to pursue a BFA and compete for a *Community Connection Scholarship* valued between \$1000 and \$6000.

•Congratulations to RVCC student Noah Motz on being selected as a 2019 *Coca-Cola Leaders of Promise Scholar*. Noah will receive a \$1000 scholarship, one of two hundred Phi Theta Kappa members nationwide to receive such recognition.

•Recently, Professor Lynne Kowski provided an update about the progress of a former Honors student, Steven Valencia. Steven is at Northeastern studying computer science and psychology. He's taking advantage of Northeastern's signature co-op program and making excellent academic progress. An important reminder about the value of our Honors College.

•I wanted to acknowledge the success of our workforce colleagues in securing a number of grants that support initiatives around apprenticeships. This table highlights three recent successes:

# <u>Library</u>

During the week of July 29, Janelle Bitter, Systems & Technical Services Librarian, attended the ARL Digital Scholarship Institute at the University of Rochester with a full scholarship. The institute is a five-day event consisting of workshops and discussions intended to give participants the skills to describe how digital scholarship fits into higher education, how and why academic libraries are engaging in digital scholarship, and how they as librarians can lead, facilitate, and collaborate on digital scholarship projects on their campuses.

### Science and Engineering

Congratulations to six STEM majors from Raritan Valley Community College for being selected to attend the Rider STEM Summer Institute from July 25 to 28 at the Lawrenceville campus. The STEM Summer Institute, which was limited to 20 potential community college transfers from New York, New Jersey, Pennsylvania, and Delaware, selected students based on their academic merits and commitment to continuing their STEM education, which is also a testament to our faculty.

### Visual and Performing Arts

#### Faculty Activities:

The first exhibition in the College Art Gallery is a memorial exhibition of the art work of the Christopher Brand Koep, full time drawing and painting professor, who passed away last August. *Christopher Brand Koep...Images of Life...* opens on August 28. The reception is scheduled for Friday, August 30 from 5-7 p.m. in the College Gallery. The exhibition, curated by Gallery Coordinator Darren McManus, runs through September 18.

Ann Tsubota will be exhibiting her art work in Women Artists on the *Leading Edge: Celebrating Douglass College* at 100 at the Zimmerli Art Museum of Rutgers University. The exhibition highlights women artists who studied at Douglass College and are interviewed in the book written by Rutgers University Professor Emeritus Joan Marter titled *Women Artists on the Leading Edge: Visual Arts at Douglass College.* The exhibition runs from September 3, 2019 through January 11, 2020.

Adjunct Cynthia Teeters has completed 10 hours of professional development to master Git and GitHub and is now a certified GitHub Campus Advisor.

Loretta Fois presented at the International Conference of Dalcroze Studies in Katowice, Poland this summer. Her presentation was titled *LISTENING TO THE VOICE OF THE BODY IN MOTION: ESPRESSIONE CORPOREA AS A TOOL TO A MORE DYNAMIC INTERACTION BETWEEN MOVEMENT AND MUSIC.* ICDS presents the best of current research and practice within Dalcroze Studies and is open to viewpoints from education, the arts and humanities, and the social, natural, health, and life sciences.

Adjunct Heejung Kim is participating in a group exhibition, entitled "Korean Art in Flux" at Art Appel Gallery at Neofitou Vamvas 5, Kolonaki in Athens, Greece. The exhibition, which began on July 11 runs through September 11, 2019. Heejung Kim will also participate in "Art Athina" an art fair at Zappeion Mansion in Athens, Greece from September 13 to 16, 2019.

<u>Resolution #138-2019 Adjustment to the Public Bid Threshold for County Colleges</u> WHEREAS, N.J.S.A. 18A:64A-25.3 established the bidding threshold at \$25,000.00; and

WHEREAS, N.J.S.A. 18A-64A-25.3(b) gives authority to the Governor and the State Department of the Treasury to adjust the bid threshold in direct proportion to the rise or fall of the Consumer Price Index for all urban consumers in the New York, Northeastern New Jersey and Philadelphia areas as reported by the U.S. Department of Labor; and

WHEREAS, this adjustment is performed every two (2) years; and

WHEREAS, from January 7, 2004 through July 1, 2017, the State Treasurer has adjusted the bidding threshold for County Colleges from \$25,000.00 to \$35,300.00; and

WHEREAS, on July 1, 2019, the State Treasurer adjusted the bidding threshold for County Colleges from \$35,300.00 to \$36,400.00.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of Raritan Valley Community College permits the bidding threshold to be adjusted to \$36,400.00 for College procurements requiring bidding in accordance with N.J.S.A 18A:64A-25.3.

Resolution #140-2019 Emergency Replacement of the Theatre Transformer

WHEREAS, the transformer that serves both the Theatre and Library areas completely failed and initial trouble shooting determined that repairs were not possible; and

WHEREAS, the situation was considered an emergency due to the significant outside rental activities which were planned for that weekend as well as the subsequent three weeks, while a normal process to solicit bids for repairs/replacement would have required at least 30 days ; and

WHEREAS, with time being of the essence to mitigate a negative financial impact and insure continued service of electrical generation capabilities that support various cooling and life safety applications for the Theatre, Library and other administrative areas; and

WHEREAS, management contacted its primary high voltage electrical services contractor to assess the situation which resulted in the successful procurement and installation of an available transformer which normally would have had a 6 to 8 week lead time; and

WHEREAS, in accordance with N.J.S.A. 18A: 64A-25.6, any purchase, contract, or agreement may be made, negotiated, or awarded by a county college without public advertising for bids, when an emergency affecting the health, safety, or welfare of occupants of college property requires the immediate delivery of the materials, or supplies, or the performance of the work required to rectify such conditions; and

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of Raritan Valley Community College authorizes the Vice President Finance and Facilities to pay the invoices related to the Theatre transformer replacement to the following company:

Resolution #141-2019 Emergency Replacement of Exhaust Gas Turbo Charger

WHEREAS, the College depends on its cogeneration facility to generate a significant amount of electricity at an attractive cost which is important to the viability of its operating budget and campus operations; and

WHEREAS, certain significant equipment replacement and repairs are required to insure that the cogen's performance meets the New Jersey Department of Environmental permitting requirements; and

WHEREAS, with time being of the essence to mitigate a negative financial impact and insure continued service of the electrical generation capabilities that support various cooling and life safety applications; and

WHEREAS, in accordance with N.J.S.A. 18A: 64A-25.6, any purchase, contract, or agreement may be made, negotiated, or awarded by a county college without public advertising for bids, when an emergency affecting the health, safety, or welfare of occupants of college property requires the immediate delivery of the materials, or supplies, or the performance of the work required to rectify such conditions; and

#### Resolution #152-2019 Financial Advisor for Public Private Partnership

WHEREAS, the Board of Trustees has previously endorsed Management's pursuit of a variety of options to explore student housing on campus as a way to not only increase student enrollment but also to improve the total college experience; and

WHEREAS, Management had engaged a research firm in 2017 to conduct a survey in the region that demonstrated that there was significant demand for housing should the College have such facilities available; and

WHEREAS, the State of New Jersey passed legislation in 2019 that would enable public entities including community colleges to establish public private partnerships for the purpose of building particular facilities including student housing that would then have access to tax exempt financing; and

WHEREAS, to insure successful applications to New Jersey Treasurer's demonstrating project viability as well as to advise the College on debt structure and agreements with potential development partners, it is desirable to engage a specialty financial advisor who has done similar work with other entities and four year NJ colleges; and

WHEREAS, the College distributed 11 Requests for Proposals and 3 firms responded on the August 13, 2019 due date; and

WHEREAS, Management needs additional time to interview the candidates whose proposals indicated hourly rates ranging from \$175 to 250/hour, all of which would become chargeable to the project cost.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of Raritan Valley Community College authorizes Management to select a firm to advise the College in a variety of areas related to the establishment of student housing on campus. The contract award will be affirmed at the next board meeting.

# Resolution #153-2019 Arts Building Project Architect Fee

# Resolution #157-2019 Legacy Sabbatical Program

WHEREAS, Raritan Valley Community College recognizes the need to improve its institutional flexibility in managing and staffing academic programs as the national higher education sector is undergoing significant structural and demographic changes; and

WHEREAS, College management has proposed a Legacy Sabbatical Program (LSP) for tenured faculty members who meet certain eligibility criteria and apply for participation on or before October 1, 2019 for Spring 2020 and April 16, 2020 for Fall 2020; and

WHEREAS, the eligible participants would receive a half-year sabbatical for the Spring 2020 term or the Fall 2020 term paid at the rate of half their base annual salary, and relinquish their tenure as of June 30, 2020 for Spring or December 31, 2020 for Fall; and

WHEREAS, the President reserves the right to recommend accepting participants based on college and department instructional needs, subject to approval by the Board of Trustees; and

WHEREAS, upon recommendations by management, the Board of Trustees reserves the right to consider offering the LSP in subsequent years;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of Raritan Valley Community College does hereby approve the Legacy Sabbatical Program for full-time tenured faculty.

### C. Labor Relations Committee

Chairman Robert Wise reported that Committee met earlier and that updates on negotiations will be made to the Board as it progresses. The Chairman noted that the Board is open to resolving issues as soon as possible.

# D. Governance Committee

Trustee Paul Hirsch reported that in an effort to enhance communication concerning important issues such as budget, student housing, strategic planning, and other key topics, a non-mandatory monthly information session will be held for all trustees before each Board meeting. These sessions will also reinforce best practices relating to effective Board Governance as required by the Middle States Commission on Higher Education. In addition, an educational workshop will be planned late in the fall semester and that the potential topic and facilitator will be forthcoming.

The annual Board self-evaluation will commence in the fall 2019. The Survey Monkey instrument will be reviewed at the September Committee meeting and then sent out to the full Board of Trustees before the October Board of Trustees meeting. The Committee recommended that Trustee Windrem oversee the process as she has graciously done in the past.

As required by the State of New Jersey, the Campus Safety Report for the period June 13, 2019 to August 14, 2019 was discussed by the Committee and provided to the full Board of Trustees via SharePoint.

The Committee received a report on the progress on addressing items from the Prosecutor's *Risk Assessment and Security Report*, specifically relating to phones in classrooms, employee instructions on contacting 911, securing electronical panels, ensuring the lockdown ability for classrooms and upgrading various doors, security office hardening, and exterior cameras, as well the associated expense. The Governance Committee will continue to review the monthly progress report and will keep the full Board apprised.

Trustee Paul Hirsch then presented the following resolution for the full Board's consideration:

Resolution #158-2019 - Continued Improvements to Campus Safety

WHEREAS, Raritan Valley Community College has an unwavering commitment to being an inclusive, respectful, and safe community for all who work, study, and visit campus; and

WHEREAS, the Board of Trustees by Resolution #134-2019 acknowledged receipt of the Risk Assessment & Security Report assembled by the Somerset and Hunterdon Counties Prosecutors Offices' Critical Infrastructure Assessment Team; and

WHEREAS, the President's internal safety oversight committee, in an ongoing effort to enhance campus safety, has completed several infrastructure improvements recommended in the assessment as well as other essential actions relating to procedure, training, and safety awareness; and

WHEREAS, the Board of Trustees acknowledges, accepts, and applauds the measures being implemented to enhance campus safety; and

WHEREAS, the President and the Board of Trustees will continue to diligently implement the Assessment Team's comprehensive recommendations and explore new methods to further improve safety;

NOW, THEREFORE, BE IT RESOLVED, that the President and the Board of Trustees extend their deepest appreciation to the Somerset County Prosecutor's Office and the Hunterdon County Prosecutor's Office for conducting such a thorough and insightful risk assessment and security overview of the College to assist in our ongoing effort to the make Raritan Valley Community College a safe and secure learning environment for all; and

BE IT FURTHER RESOLVED, that the President and the Board of Trustees of Raritan Valley Community College further recognize and vigorously support the establishment of a Public Safety Training facility on campus.

The Resolution was moved by Trustee Hirsch, seconded by Trustee Simon, and unanimously approved by voice vote.

The Committee endorsed travel for Chairman Wise and President McDonough to attend the ACCT Leadership Congress in October 2019. The ACCT Leadership Congress is the largest professional development opportunity for community college trustees, presidents, policy leaders, and staff, designed to advance governance and student success and is a platform through which to share their expertise concerning public policy.

IV. Old/New Business

Chairman Wise noted that NJCCC has created a framework for the future of NJ's community colleges – VISION 2028 – a broad and ambitious effort to better assist New Jersey's residents to obtain the skills and knowledge necessary to succeed. The Chairman will keep the Board apprised as efforts progress.
