RARITAN VALLEY COMMUNITY COLLEGE BOARD OF TRUSTEES' REGULAR MEETING NOVEMBER 12, 2019

MINUTES

I. Call to Order

The Regular Meeting of the Board of Trustees of Raritan Valley Community College was held on Tuesday, November 12, 2019, at Raritan Valley Community College, Route 28 and Lamington Road, Branchburg Township, North Branch, New Jersey.

Chairman Robert P. Wise called the Regular Board of Trustees meeting to order at 5:15 p.m., and made the following statement in compliance with the Open Public Meetings Act of the State of New Jersey:

Introduction – Foundation Board Chair

Stacey Kimmins, Chair of the Foundation Board of Directors, introduced herself to the members of the Board of Trustees and indicated that she looks forward to working with them in her new role.

Middle States Presentation

Dr. Patrice Marks, Dean of Liberal and Fine Arts and MSCHE Accreditation Liaison Officer, provided an update on the College's Self-Study Preparation visit by our Middle States Accreditation Commission Staff Liaison (Dr. Robert Bonfiglio) to our campus in spring 2020. Dr. Bonfiglio will meet with the Self-Study Committee Chairs and the Board of Trustees during his visit (details to follow.)

Swearing-In New Board of Trustees Members

III. Agenda Items

1. Approval of Regular Meeting Minutes

On motion by Trustee Rica, seconded by Trustee Hirsch, the Regular minutes of September 17, 2019 were approved by voice vote.

2. Chairman's Report

Chairman Robert Wise announced that the Annual RVCC Foundation Trip Raffle tickets are now available to purchase and that the drawing is scheduled for January 3, 2020. The annual fundraising effort benefits the RVCC scholarship fund.

The Chairman then presented the following resolution, as follows:

The resolution was moved by Chairman Wise, seconded by Trustee Bateman, and approved unanimously by voice vote.

3. President's Report

President Michael McDonough reported that for the first time in our Athletics' program history, the Women's Volleyball Team are NJCAA District L and NJCAA Region XIX Champions. On behalf the College community and Board of Trustees, the President expressed his congratulations to the team and to the coaches.

The President remarked that the RVCC's Authentic Engineering Experience continued its track record of innovation and success in 2018-2019. The program features team-based projects in which groups of 2-4 students solve a real problem for a real customer in one semester. All AEE projects are funded by the RVCC Foundation through the generous support of donors to the College.

The AEE Teams' successes included the following initiatives in 2018-2019:

- A device for LabCorp to increase the process throughput and precision of an existing medical test that requires placing two antibiotic-saturated paper discs onto a bacterial growth at a separation of 12+-0.5mm. The device is currently being qualified by LabCorp for use in production.
- A Hunterdon Transformer project featuring a finite-element based mathematical model and Graphic-User-Interface (GUI) to reduce the customer quotation time for transformer design by a factor of 10-20 times. The customer is qualifying the model and GUI in its quotation process.

- A fully designed "Electrical Energy Generation" professional development training seminar for Duke Farms designed for fourth grade teachers. The seminar includes multiple sets of hands-on demonstrations that will be available, on loan, to local schools in fall 2019.
- A Bohler Engineering project for an access road on difficult terrain that includes vertical and
 horizontal road alignment, grading, and culvert design based on a complete drainage analysis. The
 project included learning and applying an important civil engineering design software (Civil 3D) and
 adhering to local road design codes and requirements. The quality of the work and the effort it required
 earned both students involved paid summer internships—one at Bohler and one at Ferriero Engineering.
- An automated blood-sample tube barcode-reading device that reads the barcodes and generates recall inventory locations. The six-second process is far faster than hand-scanning each tube. The technology is applicable to companies such as LabCorp, but the project was not specifically sponsored by LabCorp

The President provided an update on NJCCC's legislative strategies and vision for their proposal to the Governor and legislature for an increase in operating funds. The President indicated that there is a proposal in the House of Representatives for a comprehensive reform of American high education called "the College Affordability Act" which seeks to restore state and federal spending on public institutions, which would lower the cost for students and their families.

Highlights from President's Messages

- •In New Jersey, the manufacturing sector generates \$49.3 billion a year and employs over 247,000 workers. The average salary is \$92,097 per year. There are about 7,000 manufacturing companies in the state and the rapidly evolving industry needs highly skilled workers. Recent New Jersey initiatives the \$500 million bond for vo-techs and community colleges and the launch of the Apprentice Network promise to make the community college sector a key partner in the support and development of this crucial industry sector. I am delighted that RVCC's talented workforce staff are making our College such an innovative and agile leader in this area.
- •Susan Dorward reports that RVCC has a STARS Sustainability rating of 59.69, a silver-level rating. This rating makes RVCC the 4th highest rated community college in the nation (1st in the "air and climate" category). Congratulations to all the member of the RVCC community who made this recognition possible.
- •Congratulations to Professor Carol Patterson. She is the 2019 recipient of the New Jersey League for Nursing Nurse Recognition Award. As Professor Beryl Stetson notes, Carol is an exemplary colleague and a "luminary" within the profession: "she sets the benchmark for excellence."
- •Federal law requires RVCC to publish an annual security report. The 2019 Annual Report can be accessed at www.raritanval.edu/2019AnnualReport
- •A new transfer agreement between RVCC and Kutztown University will prompt a more fluid transfer process between the two institutions. In addition, by submitting a "letter of intent," RVCC students will be eligible for greater opportunities in academic scholarships and a one-time book award of \$500.
- •My thanks to Lonny Buinis for sending me an article from *Campus Technology*. Rhea Kelly's article highlights three institutions that have improved degree completion rates and offers a brief summary of the innovative strategies that adopted to achieve these measurable successes:

University of Central Florida

- •prepared first-generation and low-income students for STEM careers;
- •mentored African American students to achieve personal, academic, and career goals;
- •offered a completion grants program to address financial needs.

UNC Charlotte

- •newly designed "A Prospect for Success" curriculum for first-semester students;
- •new technologies to identify emerging indicators of academic risk;
- •a graduation metrics platform to help departments identify barriers to completion.

University of Rhode Island

- *strategic investments in new advising and curriculum maps;
- •new Teaching and Learning office;
- •increased focus in high-impact experiential learning;
- •adopting an early-alert system;
- •creating a "winter term" to help students get back on track.

The 2018 voting rate of 41.4% represents a 27.1% increase since 2014.

Items of Note

Library

Associate Professor Alyssa Valenti and Instructor Janelle Bitter presented at the C2 Summit for Pedagogical Advancements in STEM held at Raritan Valley Community College on October 18, 2019. Their presentation was titled, "Scientific Research and Information Literacy." Janelle spoke about integrating information literacy into a STEM course by proposing a sample activity that encourages critical thinking about source types and how various information is presented. Alyssa spoke about a live example of information literacy in a nursing course by having students interact with a scholarly journal and answer questions about their understanding by using a library created learning object and assessment.

Athletics Fall Sport Recap

For the first time in program history, the Women's Volleyball Team are NJCAA District L and NJCAA Region XIX Champions. In a tough battle versus RCSJ-Gloucester, the Lions won in straight sets, 25-21, 25-11 and 25-20. Hannah Chiswick (Del Val H.S.) and Tess Rogovin (North Hunterdon H.S.) were honored as Tournament MVP and member of the All-Tournament Team, respectively.

The National Championship Tournament will be a 12-team bracket and held at UCR Regional Sports Center in Rochester, MN. November 14-16, 2019. The team will be leaving Tuesday November 12, 2019.

Congratulations to the Team, Head Coach Phil Herro, and Assistant Coach Kelsie Fleming.

Congratulations goes out to Men's Soccer as well. The team won their first playoff match in over a decade at the NJCAA Region XIX Championship Tournament where they faced Northampton Community College in the 1st round and won 4-0. Advancing to the 2nd round, they faced #1 seed Camden County and unfortunately lost. The progression of the team over the past 5 seasons and ability to compete shows the resilience and recruiting ability

of Head Coach Mark Malchow.

WHEREAS, based on an analysis of website usage, enrollment data and market research, eDesign Interactive has proposed a \$279,000.00 campaign covering the period January 1, 2020 through June 30, 2020 which combines digital marketing with website maximization; and

WHEREAS, \$50,000.00 in funding is available from the Community College Opportunity Grant Planning Project and the remaining \$229,000.00 is available from the Fiscal Year 2020 Public Relations Operating Budget to support these digital marketing services; and

Resolution #187-2019 Solar Power System Installation and Operation Update

WHEREAS, the College advertised for bids to provide the financing, design, engineering, materials, installation, operation and ownership of a Solar Power Energy System which will capture the solar resources at the Workforce Training Center building; and

WHEREAS, the Board of Trustees of Raritan Valley Community College authorized EZNERGY NJ, LLC to install and operate a Solar Power Energy System on campus utilizing a 15-Year Power Purchase Agreement (PPA), via Resolution #164-2019; and

WHEREAS, the College received a bid protest from Ferreira Construction Company, Inc. disputing the maximum size that the solar power system can be built by law; and

WHEREAS, The New Jersey Clean Energy Act, P.L. 2018, Chapter 17, Section 6, limits the size of any new solar power system to the average Kilowatt Hour (kWh) consumption for that metered account over the previous 12 month period; and

WHEREAS, the College's bid specifications did not seek proposals offering the maximum allowable facility size, but instead clearly solicited bids for a 240kW system; and

WHEREAS, after careful analysis of the situation, none of the proposals received conformed to the solar power system size set forth in the bid specifications; and

WHEREAS, N.J.S.A. 18A:64A-25.15 states that no bid shall be accepted which does not conform to the specifications therefor consequently allowing any county college to reject all bids; and

WHEREAS, re-bidding the project would allow RVCC to ensure that all bid proposals are consistent with the bid specifications and remove all doubts and concerns relating to the bid award; and

NOW, THEREFORE, BE IT RESOLVED, the Board of Trustees of Raritan Valley Community College hereby authorizes the revocation of Resolution #164-2019, the rejection of all bids related to this project and authorizes the Director of Purchasing to publicly re-bid this project.

D. Labor Relations Committee

Chairman Robert Wise commented that the Labor Relations Committee did not meet earlier, but noted that a mutually agreed upon negotiations session with the Faculty Federation is scheduled for November 15, 2019.

E. Strategic Planning Committee

Trustee Tracy DiFrancesco reported that the Committee reviewed the 2019 Strategic Plan dashboard with administration. The 2019 updated metrics will be available on the RVCC's public website by January 1, 2019 and detailed information about each metric will also be available.

F. Governance Committee

Trustee Paul Hirsch reported that the Committee was provided with an update on FY budget results and winter and spring enrollment figures; on the Campus Safety Report for the period September 9 to October 31, 2019; on campus safety progress addressed in the Prosecutor's *Risk Assessment and Security Report*; and on some of the *Building our Future* initiatives.

It was further reported that a Board educational retreat will be planned for spring 2020; that the Committee appointed Nominating Subcommittee members Paul Hirsch (Chair), Andrew McNally, and Juan Torres and that the slate of officers for 2020 will be presented to the Board at their Annual Reorganization meeting; and that a copy of the proposed 2020 Board meeting schedule was distributed for review.

Resolution #196-2019 Recognition of Service, Patrick J. Fittipaldi, Director Emeritus, RVCC Foundation Board of Directors

WHEREAS, Patrick J. Fittipaldi, Director Emeritus, Board of Directors of the RVCC Foundation, and Foundation Director for 37 years;

WHEREAS, In consideration of Mr. Fittipaldi's influence on major developments at the College, through his leadership as a Somerset County Freeholder, Raritan Valley Community College Trustee, and as a Raritan Valley Community College Foundation Board member;

WHEREAS, Mr. Fittipaldi has helped to secure sustained and significant philanthropic support for the College;

WHEREAS, Mr. Fittipaldi's leadership and service in the community have been widely recognized, including as Plainfield UNICO Man-of-the-Year, 1978; County Officers Association of New Jersey, 2000; Spirit of Somerset County Award, 2001; RVCC Service Award, 2005; North Plainfield High School Hall of Fame, Class of 1948, 2005; and Watchung Hall of Honor for Korean War Service, 2018;

WHEREAS, Mr. Fittipaldi's exemplary service as director of the Foundation has left a lasting mark on Raritan Valley Community College;

Several comments were made concerning faculty negotiations and concerning a trustee attending an external event unaffiliated with the College.
