RARITAN VALLEY COMMUNITY COLLEGE BOARD OF TRUSTEES' REGULAR MEETING DECEMBER 10, 2019

MINUTES

I. <u>Call to Order</u>

The Regular Meeting of the Board of Trustees of Raritan Valley Community College was held on Tuesday, December 10, 2019, at Raritan Valley Community College, Route 28 and Lamington Road, Branchburg Township, North Branch, New Jersey.

Chairman Robert P. Wise called the Regular Board of Trustees meeting to order at 5:32 p.m., and made the following statement in compliance with the Open Public Meetings Act of the State of New Jersey:

III. <u>Agenda Items</u>

- 1. <u>Approval of Regular Meeting Minutes</u> On motion by Trustee Rica, seconded by Trustee Nace, the Regular minutes of November 12, 2019 were approved by voice vote. Trustees Jinks, McNally, and Torres respectfully abstained.
- 2. <u>Chairman's Report</u>

Chairman Robert P. Wise expressed his appreciation to the Board of Trustees for their vote of confidence in re-electing him Chairman and noted that he is honored.

3. President's Report

President Michael McDonough distributed a copy of his written report, as follows:

Highlights from President's Messages

The RVCC Phi Theta Kappa chapter is tackling the significant issue of textbook costs. As our students note, students can spend an average of \$1200 a year on textbooks. In some cases – perhaps more than we care to

acknowledge – students cannot afford to purchase these materials and the impact on student success is immediate and dramatic. Other research shows that as many as 35% of students take fewer classes in order to meet the cost of textbooks. And 24% of students have reported withdrawing from a class because they could not complete the assignments or achieve a passing grade without the textbook.

At the community college, this problem can be acute.

Roughly 37% of all students who attend a community college have an annual income of less than \$20,000. 30% have an annual income of between \$21,000 and \$50,000. Not surprisingly, only 14% of students with a reported annual income of less than \$20,000 have completed their degrees.

To try and solve this issue, the RVCC Phi Theta Kappa chapter is establishing three \$200 books scholarships. After meeting with our very dedicated, enthusiastic, and accomplished students, I said I would promote their initiative. Items of Note

RVCC Earns National Recognition for Student Voter Engagement

Raritan Valley Community College has earned a "gold seal" in the 2019 ALL IN Challenge Awards for its student voter engagement. The awards recognize colleges and universities across the country that are committed to increasing college student voting rates. Institutions that earn a gold seal have achieved a student voting rate between 40-49 percent.

RVCC was among the <u>schools recognized</u> at the ALL IN Challenge Awards Ceremony, held November 12 at the Newseum in Washington, DC.

According to the National Study of Learning, Voting, and Engagement (NSLVE), an initiative of Tufts University's Institute for Democracy & Higher Education, voter turnout at the more than 1,000 institutions participating in the study increased by 21 points, from 19 to 40 percent, from the 2014 to 2018 elections. RVCC's student voting rates increased from 14.4 to 41.4 percent during that period. The biggest increase in numbers of voters at RVCC occurred in students ages 18-21, with a 32.1 percent increase.

RVCC students' increased engagement in the voting process was fostered by a \$1,850 mini-grant to participate in "Engage the Elections: 2018," a project that aimed to advance non-partisan electoral engagement on community college campuses. The project was part of Campus Compact's new program, Community Colleges for Democracy. RVCC was one of only 14 community colleges in the country—and the only New Jersey college—to be awarded the mini-grant.

Led at RVCC by Service Learning and Student Life, the College's participation in the Engage the Elections project (#RVotes Matter) was a huge success, with 138 voter registrations completed. The initiative featured a number of events on campus, including a "Puppies, Pizza and Politics" gathering led by an immigration attorney, and workshops by Dr. Elizabeth Matto, Director of Rutgers University Eagleton Institute on Politics, and "Your Story, Your Rights, Your Vote: What's Next," presented by <u>PlatformWomen.org</u>.

The <u>ALL IN Campus Democracy Challenge</u> is a nonpartisan, national initiative recognizing and supporting campuses as they work to increase nonpartisan democratic engagement and full student voter participation. The Challenge encourages higher education institutions to help students form the habits of active and informed citizenship, and make democratic participation a core value on their campus. More than 560 campuses, enrolling more than 6.2 million students, have joined the Challenge since its launch in summer 2016.

English Department

Michelle J Brazier, Associate Professor of English, chaired the Delegate Assembly Organizing Committee annual meeting in late October at the Modern Language Association headquarters in NYC. The purpose of the 2-day meeting was to plan the Delegate Assembly agenda for the MLA Annual Convention in January 2020 in Seattle, Washington.

Professor McKeown Bondhus has new work in *Cape Cod Poetry Review* and *ImageOutWrite*. He continues to tour in support of his newest poetry book *Divining Bones* (Sundress Publications, 2018.) He recently gave readings in Wilmington and in Cape May and will soon be appearing in Brooklyn, Philadelphia, and Atlantic City (at Stockton University).

Math and Computer Science Department

Youngjun Choi has successfully defended his dissertation titled "Analysis of Host-Parasitoids Systems" and will receive his Ph.D. from Stevens Institute of Technology December 2019.

George Soliman presented *Fibonacci Numbers Are Fascinating, and That's No Fib!* at the 45th Annual AMATYC Conference in Milwaukee, WI on November 15, 2019.

Communication & Languages Department

The Communication & Languages Department, in conjunction with Marketing/PR, hosted a memorial service for Harry Hillard on November 21 in the Conference Center. Students, faculty (both active and retired), administrators, family, and friends joined in the celebration of Harry's life and his significant contributions to the College. Harry captured a great deal of the College's history in still and motion pictures. He was also a beloved video production Professor and founder of our successful Digital Media/Film program.

As part of the holiday festivities around campus, Professor Sarah Greco and her American Sign Language 101 and 102 students signed Christmas carols in various classrooms and public areas on campus during the week of December 2, 2019.

Science and Engineering Department

The RVCC Authentic Engineering Experience Team presented their 3rd Project Review update on December 5 to ExxonMobil. The RVCC Team presented their prototype process and machine that separates catalyst particles into specific size ranges. The catalyst particles are used by ExxonMobil in their extensive Pilot-Plant facilities in Annandale, which supports operations worldwide.

The ExxonMobil Team – who will receive this prototype for use – was very impressed and fully supportive of the RVCC Team's quality of data. Efforts to finalize a fully functioning prototype is scheduled for a final review in January and plans are already in place for a follow-on RVCC Team to industrialize the process in Spring 2020 and potentially other projects.

C. Audit Committee

The Public Meeting reopened to the public at 5:48 p.m.

D. Labor Relations Committee

Chairman Robert Wise reported that the Committee met earlier and unanimously recommends the following resolution:

- 1. 2019-2021- 2.5% salary increase each year.

- 3. Health care related and Educational reimbursement changes.
- 4. Advising pay: \$45 capped at 10 hours per semester.
- 5. Class size limits.
- 6. Sabbaticals: 3/6.
- 7. All dates throughout the collective negotiation agreement shall be adjusted to reflect the new termination date of June 30, 2022.
- 8. Agreement is for a term of three years from July 1, 2019 through June 30, 2022.

The Resolution was moved by Trustee Rica, seconded by Trustee Simon, and approved unanimously by voice vote

E. Governance Committee

Trustee Paul Hirsch reported that the Committee was provided with an update on FY 19 budget results and winter and spring enrollment figures; on the Campus Safety Report for the period November 1 to December 1, 2019; and that they also had a very productive discussion concerning the College's safety progress to date, as addressed in the Prosecutor's *Risk Assessment and Security Report*.

The Committee further reviewed and recommends for the full Board's approval the terms of the fifth amendment to the President's contract (Resolution #211-2019.) There being no questions, the President's Fifth Amendment to his contract was approved on motion by Trustee Hirsch, seconded by Trustee McNally, and approved by voice vote. Trustee Nace voted no. Several Board members congratulated the President and expressed their appreciation on his outstanding leadership of the College.

Chairman Wise indicated that it is the desire of the Board to enhance trust, responsibility, and efficacy in future collective bargaining.

VI. Public Questions/Comments

Chairman Wise read the following statement into record:

"The Board will take any comments from the public at this time. The Board will not respond to comments made and speakers are limited to two minutes. The total time allotment for public comments will be no more than 40 minutes. Speakers are to remain civil and refrain from any direct comments about Board members."

Pattiann Kletz, President of the Faculty Federation, expressed her appreciation to the President and to the Board of Trustees on the settlement of the contract and stated that she looks forward to working collectively as the adjunct negotiations commences.

VII Adjournment

There being no further business to bring before the Board, the Regular Meeting adjourned at 6:42 p.m.
