MINUTES

I. <u>Call to Order</u>

The Special Meeting of the Board of Trustees of Raritan Valley Community College was held on Thursday, February 6, 2020, at Raritan Valley Community College, Route 28 and Lamington Road, Branchburg Township, North Branch, New Jersey.

Chairman Robert P. Wise called the Special Board of Trustees meeting to order at 8:00 a.m., and made the following statement in compliance with the Open Public Meetings Act of the State of New Jersey:

The motion was moved by Trustee Hirsch, seconded by Trustee DiFrancesco Zaikov, and approved unanimously by voice vote.
