# RARITAN VALLEY COMMUNITY COLLEGE BOARD OF TRUSTEES' REGULAR MEETING DECEMBER 4, 2018

#### **MINUTES**

#### I. Call to Order

The Regular Meeting of the Board of Trustees of Raritan Valley Community College was held on Tuesday, December 4, 2018, at Raritan Valley Community College, Route 28 and Lamington Road, Branchburg Township, North Branch, New Jersey.

Chairman Robert P. Wise called the Regular Board of Trustees meeting to order at 5:23 p.m., and made the following statement in compliance with the Open Public Meetings Act of the State of New Jersey:

## III. Agenda Items

#### 1. Approval of Regular Meeting Minutes

On motion by Trustee Paul Hirsch, seconded by Trustee Caren Bateman, the Regular Meeting minutes of October 30, 2018 were approved by voice vote.

## 2. Chairman's Report

Chairman Robert Wise congratulated the faculty, administration, and staff on a great fall semester and further wished the President, the members of the Board of Trustees, and entire College community a very happy and safe holiday season and best wishes in the New Year.

The Chairman reported that the Board had an excellent educational retreat earlier in the day on student housing and the College's future strategic vision.

# President's Report

President McDonough highlighted the impressive work and well-deserved praise and recognition of two retiring professors – Deborah Corbett and Lynn DeCicco – and also that of the late Professor Chris Koep,

who sadly passed away this past summer. The President remarked that they have demonstrated outstanding teaching, impactful campus citizenship, and sustained professional development over the length of their tenure at RVCC and that RVCC is a better college because of their dedication to student success and to the signature values of the comprehensive community college. The President commented that their presence both in and outside the classroom will be missed. (The President noted that the Board of Trustees will be considering a resolution to bestow the title of Professor Emeritus to the aforementioned professors later on in the meeting.)

The President's full written report, which highlights several achievements, is provided below.

Items of Note

## Statewide Community College Spirit Award

On Friday, Nov. 16, as part of the Vision 2028 Leadership Summit, the New Jersey Council of County Colleges presented the Community College Spirit Award to Raritan Valley Community College Director of Service Learning and Community Outreach Lori Moog. The Community College Spirit Award is presented to a New Jersey community college employee to recognize his or her significant contributions above and beyond his or her day-to-day duties at the community college.

RVCC has a nationally ranked and recognized Service Learning program, thanks to Moog's vision, dedication, and exemplary partnerships with students, faculty, and community organizations. She directs the efforts of over 1,000 students who contribute over 50,000 hours of service to hundreds of local community organizations. This program provides students with unique real-world opportunities to apply classroom learning.

RVCC students have addressed such critical issues as hunger, homelessness, illiteracy, environmental stewardship, domestic violence, substance abuse, and animal welfare. As a result, the program has been named to the President of the United States Community Service Honor Roll "With Distinction" in two categories, the only community college in the country to receive this honor.

This year, RVCC's Service Learning program was honored with the 2018 New Jersey State Governor's Jefferson Award for extraordinary service to the community.

Lori Moog also has offered more than 40 professional development workshops to community college faculty and staff, highlighting the essential ingredients in a successful service learning program. She served as the project director of Developing Regional Collaboration, a project that created a regional network for community colleges in New Jersey, New York and Pennsylvania. She helped establish the first New Jersey Campus Compact, and for the past three years she has coordinated a multi-state grant from the Teagle Foundation to assess and develop students' civic and moral responsibility. She is now fully engaged in the National Democracy Commitment initiative to ensure that all community college students graduate with an education in good citizenship practices.

The award, a glass acorn atop a metal base, was designed and created through a partnership between Salem Community College and Camden County College. Salem Community College has one of the most innovative glass programs in the country and Camden County College has been a leader in New Jersey in training and educating students to work in the metal fabrication and advanced manufacturing industries. The award embodies the commitment of New Jersey's community colleges to creativity, knowledge, innovation, and collaboration.

The New Jersey Council of County Colleges is the state association representing New Jersey's 19 community colleges. As an independent, trustee-headed organization that joins the leadership of trustees and presidents, the Council is a resource that strengthens and supports the state's 19 community colleges.

Charlie Bondhus has been touring in support of his newest poetry book *Divining Bones* (Sundress Publications, 2018). In October and November he had readings in New York City, Chicago, Cincinnati, and St. Paul, MN. He also read at Jefferson Community College's (SUNY) North County Writers' Festival and met with their creative writing students.

On November 22-24, Assistant Professor Izabela Zieba participated in "Waving Borders/Affranchir la frontière," an international symposium of the research project "Out of Place: Law, Literature, and Migration" (SSHRC), organized by the University of Montreal in collaboration with La Maison de la Syrie. She presented a paper titled "Accidentally Subversive: Returns to Ancestral Homelands in Contemporary Jewish American Novels."

Visual and Performing Arts Department

Student Activities:

The Annual VAPA Holiday Art Show and Sale starts on Monday, December 3 through Friday, December 7 in the College Art Gallery. The sale will be open noon to 8 p.m. (and until 6 p.m. on Friday.) Art work and crafts made by faculty, students, and alumni will be available for sale. The show and sale is coordinated by Professor Ann Tsubota.

Dance Works, an evening of student and faculty choreography will be performed in the Nash Theatre on December 4 and 5 at 8:00 p.m.

The RVCC Arts performance will be on December 6 at 1:30 in the Welpe Theatre. Loretta Fois is the producer.

The RVCC Jazz Ensemble concert will be held on December 6 at 7:30 p.m. in the Welpe Theatre. Adjunct John Loehrke is the director.

The annual Holiday Concert by the RVCC Chorale will be performed on Saturday, December 8 at 8 p.m. in the Welpe Theatre. The chorale is directed by Professor John Sichel.

#### Faculty Activities:

In September selections from John Sichel's *Duets for Our Times* was performed in three concerts in Germany by Vladimir Tsypin (violin) and Irith Gabriely (clarinet). The three movements performed were "Political Debate as a Means of Seeking a Deeper Truth," "Relax the past was even worse," and "the Normalization of Madness."

Loretta Fois presented on *Espressione Corporea: Making connections between artistic disciplines and body movement* at the National Dance Education Conference in San Diego this October. As Vice President of Dance New Jersey, Loretta also a co-presented on *Unifying Dance Throughout One State: Building Dance New Jersey as a Resource, a Service, and a Voice.* As a performer, Professor Fois's work *With only the clothes on our backs*, was presented at the American Dance Guild Festival at the Ailey Center, NYC on October 27<sup>th</sup>, and at the SMUSH Festival in Jersey City on November 30<sup>th</sup>. Additionally, she led a professional development workshop, *Espressione Corporea: A study in cross-disciplinary engagement,* for K-12 teachers and sponsored by DanceEdNJ on the Move on November 15<sup>th</sup>.

Bill Crosbie will be coordinating the 2019 Global Game Jam with assistance from John Harford and Steve Caruso. The event in the West Building will run from January 25-January 27, 2019. It is the 9th time we will be hosting the event at RVCC.

A large scale mural designed by Ji Yong Kim was completed in Brooklyn, NY. Located in a backyard of a hidden shelter for domestic violence victims of women and children, the mural was painted with a help of volunteers from Morgan Stanley, New York Cares, NYU students, and more.

In October, Ji Yong Kim was commissioned a permanent large installation work in the display windows of VIA 57 apartment building in NYC. The installation titled "Sun, moon and 5 mountains" depicts a large scale

landscape based on a traditional Korean painting. The installation was successfully completed and is now on view located in 12th Avenue/58th Street. Ji Yong Kim won a mural design competition to be painted in Freeport, Long Island. This 20 foot tall by 50 foot long mural is located on the exterior wall of Freeport Memorial Library, and funded by a grant from Freeport Arts Council of Long Island. The mural is aimed to be completed by early December.

After participating in a successful group exhibition this summer at Beaudry Gallery in Dallas, Texas, the gallery has added Darren McManus to their list of gallery artists. His gallery representation begins with an exhibition titled, "Sanctuary" opening Thursday, November 17<sup>th</sup> and runs to mid-January, 2019. McManus will have all six of his four-foot diameter paintings from his Rose Window series in the exhibition, along with an installation consisting of 37 circular paintings presented in a large geometric composition. Additionally, in early November, Professor McManus served as the sole juror for the Virginia Center for the Creative Arts International Residency Program at the Salzburg Künstlerhaus in Salzburg, Austria. As a former recipient of this prestigious fellowship (2011), McManus was asked to evaluate the pool of applications and select the lone recipient for this 2019 Summer residency. The program provides an opportunity for the selected artist to spend six weeks in the Künstlerhaus, located in the heart of Salzburg, to focus on their work.

In 2017, Darren McManus was hired to rebrand Ajiri Tea and Coffee. This six-month project included a complete re-design of their visual identity and full-range of tea and coffee packages. Since completion, sales, distribution and partnerships have all increased with Ajiri Tea and Coffee products now available in several hundred stores across the United States including: Whole Foods, Bed Bath & Beyond, Blue Apron, Dean and Deluca, and the Smithsonian National Museum of African Art. Most recently, *Forbes* named *Ajiri's Coffee and Tea Gift Set* as one of the nine best gift sets in their "tea and coffee" category for their 2018 Forbes Holiday Gift Guide.

Steve Hudson, adjunct professor of music, composed the score for the short film, "A Still Water Runs Deep" written and directed by Abbesi Akhamie. The film is a heartfelt film about a father and his son in Nigeria. The film was most recently screened at the BFI film festival in London, and was nominated for a 2018 African Academy Award.

Ann Tsubota and Adjunct Bill Macholdt will be teaching a two-day ceramics workshop sponsored by the Hunterdon Art Museum on January 12 and 19.

The application for <u>THAT</u>'s 3rd annual tour opens December 1, 2018. Val Sivilli created The Hunterdon Art Tour in 2016. <u>THAT</u>'s tour this year is on May 4th-5th 2019. On the 3rd, The Hunterdon Art Museum will showcase a sample of each artists work with a Gala opening. ## Campus Safety Update

Recently, the President met with Somerset County Prosecutor Michael Robertson and Hunterdon County Prosecutor Anthony Kearns regarding campus safety. Raritan Valley Community College is classified under the official command of the Somerset County Prosecutor and Branchburg Police Department is our first call/responders. Prosecutor Robertson and Kearns will conduct a comprehensive "needs assessment" of the RVCC campus. Both Prosecutors noted that the College is doing an excellent job with campus safety.

As required by the State of New Jersey the Committee also reviewed the Campus Safety Report for the period October 15 to November 20, 2018.

## **Building Our Future**

The Committee discussed the President's robust presentation held earlier in the day at the Educational Retreat concerning student housing and the College's future strategic vision. The Committee discussed the urgency of moving forward on student housing. The full Board of Trustees will also discuss potential land use opportunities during an Executive Session at the Regular Board of Trustees meeting.

## Forum's No Smoking Policy

For informational purposes, the Committee received the College's proposed nonsmoking policy.

#### Trustee Retreat

An Educational Retreat on Board Governance will be scheduled during the spring 2019 semester. The Committee unanimously recommended bringing in an outside consultant from the Association of Community College Trustees (ACCT) to provide a "Trustee Talk" presentation on Governing Board roles and responsibilities and to answer questions about issues affecting boards today.

#### C. Finance Committee

Trustee Margaret Windrem reported on the Treasurer's Report (Resolution #175-2018) for the period 10/01/18 to 10/31/18. On motion by Trustee Windrem, seconded by Trustee Howes, the Treasurers' Report was approved unanimously by voice vote.

Trustee Windrem presented Consent Agenda Resolution #176-2018 and Resolutions #178-2018 through #187-2018. On motion by Trustee Windrem, seconded by Trustee Torres, the above stated Consent Agenda resolutions were approved unanimously by voice vote. Resolution #177-2018 (Application for Amendment of the Perkins CTE Grant) was removed from Consent Agenda and voted on separately. #### Resolution #177-2018 Application for Amendment of the Perkins CTE Grant

WHEREAS, the Board of Trustees of Raritan Valley Community College previously approved a resolution on October 30, 2018 to formally accept funds for the Carl D. Perkins Career and Technology Education (CTE) Improvement Act of 2006 grant in the amount of \$332,632 to provide quality occupational program improvements and ensure access to these programs; and

WHEREAS, several budget line items will be reallocated especially in Digital Media/Video and Gaming for a lab technician, additional new equipment in Automotive due to reduced pricing, additional repairs in Ophthalmic Science, other funding source used or an inability to attend conferences, and additional computers needed in Interior Design and Computer programs, as be part of the amended budget in Perkins eligible programs; and

WHEREAS, the New Jersey Department of Education (NJDOE) requires an application for amendment to be processed for new equipment and revised budget lines that exceed the threshold on the Perkins CTE grant according to the Perkins FY19 guidelines; and

WHEREAS, the Board of Trustees has determined that funding for these project activities will continue to enhance the quality of the College's educational offerings; and

WHEREAS, a formal recognition of the Perkins Grant amendment by Board Resolution is required;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of Raritan Valley Community College approves the application for amendment of the Perkins CTE grant.

# Resolution #178-2018 Digital Marketing Campaign

WHEREAS, the Board of Trustees of Raritan Valley Community College has supported marketing strategies including digital campaigns and website enhancements in order to heighten the College's image in the community and to support enrollment; and

WHEREAS, the Board of Trustees via Resolutions #177-2017 and #79-2018 authorized eDesign Interactive to conduct a digital marketing campaign and website enhancements in order to promote Fall 2018 enrollment; and

WHEREAS, the combined digital marketing campaign and website enhancements have produced positive results, contributing to increases in attendance at recruitment events, inquiries for admissions information and new visitors to the College's website; and

WHEREAS, continued investments in digital marketing campaigns and website monitoring and enhancements are essential components in generating new student enrollment among recent high school graduates and adult learners for 2019 and beyond; and

WHEREAS, based on an analysis of website usage, enrollment data and market research, eDesign has proposed a \$161,000.00 campaign which combines digital marketing with website maximization for the sixmonth period of January 1, 2019 through June 30, 2019; and

WHEREAS, these services are considered professional services and therefore exempt from public bidding in accordance with N.J.S.A. 18A:64A-25.5(a) (1); and
