MINUTES

I. <u>Call to Order</u>

The Regular Meeting of the Board of Trustees of Raritan Valley Community College was held on Tuesday, October 18, 2016, at Raritan Valley Community College, Route 28 and Lamington Road, Branchburg Township, North Branch, New Jersey.

Chairman Robert P. Wise called the meeting to order at 5:15 p.m., and made the following statement in compliance with the Open Public Meetings Act of the State of New Jersey:

"Adequate notice of this meeting has been given in accordance with the <u>Open Public Meetings Act</u> of the State of New Jersey."

A quorum was present.

III. Agenda Items

1. Approval of Regular Meeting Minutes

The Regular Meeting minutes of September 20, 2016 were approved by voice vote. Trustee Torres abstained.

2. Chairman's Report

Chairman Robert Wise reported that the RVCC Foundation will host a donor appreciation/prospect cultivation event on Saturday, October 22, 2016, from 6:00 to 9:30 PM to thank current donors for their support and to introduce new donors to the College. Trustees are invited to join the Foundation's guests for a pre-theatre reception and the featured show *Capitol Steps*.

The Chairman reported that the RVCC Foundation is launching its first-ever 24-hour online, fundraising initiative "Giving Day" on November 17, 2016. Ronnie Weyl, the Executive Director of the Foundation, will provide additional information about the initiative during the Public Comments portion of the meeting

The Chairman announced that the Annual Board of Trustees Reorganization meeting and the Regular Board of Trustees meeting are scheduled for Tuesday, December 6, 2016; there will be no November meeting.

On behalf of the Board of Trustees, Chairman Wise extended his congratulations to President Michael McDonough for being honored by the Scouts of America. Recipients for the award were chosen for their outstanding community service leadership as well as the respect and esteem in which they are held by their colleagues. The "Toast to Scouting Awards" dinner is scheduled for Wednesday, December 7, 2016 at Raritan Valley Country Club, Bridgewater, NJ.

3. President's Report

President Michael McDonough reported that in recognition of Raritan Valley Community College's leadership role in serving the local community, the College has been named to the 2015 President's Higher Education Community Service Honor Roll "With Distinction." The College was honored in both the General Community Service and Education categories.

RVCC was the only community college in the country to be recognized "With Distinction" in the Education category. In total, only 36 institutions were recognized nationally in this category.

In addition, RVCC was one of only two colleges in the state, and the only community college in New Jersey, to be recognized "With Distinction" in the General Community Service category. Nationally, 120 higher education institutions were recognized "With Distinction" in this area.

The President remarked that RVCC students are increasingly involved in addressing and solving community problems through community service. Their participation in service learning is tied to academic coursework and organized service through student clubs as well as various community engagement activities. From non-profits, to schools, to government agencies, students serve more than 250 organizations in Somerset and Hunterdon Counties. These include pre-K-12 schools, ESL programs, after-school centers, nursing homes, adult day care centers, food banks, environmental agencies, courthouses, probation departments, youth correctional facilities, and homeless, domestic violence, and animal shelters.

On behalf of the Board of Trustees and College community, President McDonough extended his congratulations to Lori Moog, Director of Service Learning, and to our faculty for their commitment to not only educating our students, but also preparing them for a lifetime of good citizenship and leadership in addressing important community needs. The President commented that it is a true testament to the College's longstanding commitment to service learning that RVCC was the only college in New Jersey—and the only community college in the country—to be honored in both the General Community Service and Education categories.

President McDonough reported that the College held its first continuing music series to explore the relationship between music and the times in which the music is created and performed. The program, featuring the highly acclaimed Nikki Hill Band, played music that provided a lens through which to see the highly rebellious period of early Rock n' Roll. The President expressed his gratitude to Roger Shutack, adjunct history professor, for organizing an outstanding program.

The President reported that Raritan Valley Community College continues to expand global educational opportunities for its graduates with the signing of a new transfer agreement with the University of Lincoln in Lincolnshire, England. The "Agreement for Academic Co-operation" with the University of Lincoln provides an opportunity for RVCC students to continue their studies in the United Kingdom and seamlessly transfer their college credits.

Under the agreement, it was reported that students who receive an Associate of Arts in Liberal Arts – Social Science Option from RVCC may seamlessly transfer into the level two of the BS (Hons) Psychology program at Lincoln.

President McDonough indicated that this is an exciting agreement for the College as it gives our graduates the opportunity to continue their higher education and experience all of the wonderful advantages of studying abroad. As an added benefit, RVCC students transferring to Lincoln receive a 20 percent discount off tuition for each year of study at the University.

The agreement with Lincoln marks RVCC's third international transfer agreement in the past few years, following signings in 2013 with both The American University of Paris and the University of Greenwich in the United Kingdom.

President McDonough reported that he provided an introduction to the draft strategic plan to each of the Board committees in which he reviewed issues, both local and national, that confront the College. The President further reported that these issues, ranging from declining public support to enrollment challenges to the shift in focus from access to student success, have helped to shape a draft plan that is concise, focused, and inspirational. The President noted that he appreciates all the feedback from our stakeholders as the strategic plan is being developed.

Faculty/Administration/Student Highlights

Business & Public Service Department

Research by William Klinger, RVCC Associate Professor of Business, has been published in the *Journal of Financial Planning*. Professor Klinger's research offers an in-depth look at the failures arising from using several retirement withdrawal strategies.

Mathematics

Lynne Kowski presented at Hudson County College on Saturday, October 1 at the Mathematical Association of Two-Year Colleges of New Jersey conference. Professor Kowski's talk was titled: *The Role of Entry-Level Developmental English and Mathematics in Students' Success*. The study examined course outcomes in the first two levels of developmental math (MATH-015: Basic Mathematics and MATH-020: Elementary Algebra) to determine whether there is a difference in developmental English (ENGL-050: Introduction to College Reading and Composition I.) Results for MATH-015 (Basic Mathematics) and MATH-020 (Elementary Algebra) were analyzed separately to allow for examination of differences in outcomes for students who require different levels of remediation in mathematics. Statistical techniques of t-test/ANOVA were used in this study.

Visual and Performing Arts Faculty Activities:

John Sichel presented (under VAPA auspices) a concert on Monday, October 17 entitled *Music From Four Continents*. It featured Ning Tien (cello) and Roy Imperio (piano) performing John's second Cello Sonata, which was written for Dr. Tien in 1997. The concert also presented music by Yan Linda Zheng, Zhao Zhang, Shirish Korde, Astor Piazolla, and Igor Stravinsky.

John Sichel also just released a new recording, *John A. Sichel: Piano Sonatas* featuring HsinYi Tsai and Tomoko Harada playing John's Piano Sonatas in A flat (2004), B (2009), F (2011), and A (2013). The recording is available either as a CD or as a download from CDBaby.com, as well as from iTunes and other outlets.

VAPA Adjunct Professor Sarah Roche's figure drawing workshop for medical students - <u>Could art class help</u> <u>med students become more observant, empathetic doctors? -</u> at Temple University was featured on **The Pulse**, a radio program from WHYY 90.9 FM in Philadelphia. Loretta Fois presented a new work at the DUMBO festival in New York on October 2nd at the Gelsey Kirkland Theater. She also attended the National Dance Education Conference in Washington, D.C. from October 6-10 as a representative of Higher Education and an executive board member of DANCE NJ.

Music's Larry Barbee and Tony Strong served as collaborators and consultants in the organization and development of Roger Shutack's history and music series lecture offered in the Theatre on October 10. His historical topic illustrated the integration and influence of civil rights issues and dominant musical figures in the 1950's, the formative years of the development of America's Rock and Roll.

Adjunct Jonathan Ricci is included in a three person exhibition entitled *Imaginative Connection* at ZIA gallery in North Chicago. The exhibition opens on October 15 and runs until November 12, 2016.

Adjunct Sabatino Verlezza presented his choreography along with Loretta Fois at the 2016 DUMBO Festival on October 10, 2016. He also attended the National Dance Education Organization conference in Washington, DC. He will present May O'Donnell's, DANCE ENERGIES (1959) at the 2016 American Dance Guild festival at the 92ST Y in New York City on October 14, 15, 16. He will present, Weekend Intensive Dance at Creativity in Motion in Raleigh, NC on October 21, 22, 23.

Adjunct Lydia Grey (Lynn Barnes) curated two video programs for this year's Arts on Division Festival, held September 15-18, 2016, in Somerville, NJ. The screenings included work from current and past Raritan Valley students, as well as nationally-known video artists. Videos were presented in prominent storefront windows and played 24 hour a day throughout the festival.

WHEREAS, the existing campus fire alarm system, Silent Knight, is proprietary and can only be purchased through their authorized local distributor; and

WHEREAS, Fire and Security Technologies (FAST) is the authorized Silent Knight distributor for the Central New Jersey area; and

WHEREAS, N.J.S.A. 18A:64A-25.5(3) provides for the purchase of any materials or supplies which are not available from more than one potential bidder, including without limitation materials or supplies which are patented or copyrighted, without advertising for bids; and

WHEREAS, a purchase order will be issued as follows:

Fire and Security Technologies (FAST) 281 Potterstown Road Lebanon, NJ 08833 <u>Amount</u>: Not to Exceed \$122,500.00

NOW, THEREFORE BE IT RESOLVED, that the Board of Trustees of Raritan Valley Community College authorizes the Vice President for Finance and Facilities to issue a purchase order as described above to Fire and Security Technologies.

Resolution #155B-2016 Lease Renewal - North Branch Fire Company

WHEREAS, the Board of Trustees of Raritan Valley Community College had previously leased approximately 1.8 acres of land near the front of the College to the North Branch Volunteer Fire Company (NBVFC) via resolution # 153-91 for a 25-year term; and

WHEREAS, NBVFC has requested a 25-year renewal as permitted under the lease with the same terms and conditions; and

WHEREAS, resolution #122-2016 was introduced at the August 30, 2016 meeting but tabled by the Board pending clarification of renewal term options with Board counsel; and

WHEREAS, the Board counsel confirmed the propriety of the existing lease agreement and the specified renewal term of 25 years.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of Raritan Valley Community College authorizes management to sign the appropriate lease documents, reserving the right to make any changes in the best interests of the College.

D. <u>Audit Committee</u>

Trustee Peter Schoberl reported that Robert Butvilla, partner with Suplee, Clooney & Company, reviewed the preliminary analysis for the draft audit report with the Audit Committee members. The Committee will review the draft audited financial report and management letter in full detail at their next scheduled meeting on November 29, 2016.

Trustee Schoberl reported that it is time to engage in an auditor selection process and asked administration to prepare a draft RFP for the Committee's review.

E. <u>Governance, Policy and Presidential Evaluation Committee</u>

Trustee Paul Hirsch reported that the Committee reviewed the draft policy guidelines and procedures for named gift opportunities for informational purposes. He further reported that the Committee unanimously agreed that a resolution for Board approval was not necessary since it is an internal administrative operational policy of the College; hence, Resolution #156-2016 was withdrawn.

Trustee Hirsch reported that the Governance Nomination Subcommittee will seek nominations for the slate of officers for 2017, membership to the Board of School Estimate, and the NJCCC "Voting Delegate." Nominations should be sent directly to Trustee Hirsch as chairman of the Governance Committee or trustees can also make nominations at the Board of Trustees' Annual Reorganization meeting. It was reported that the proposed slate of officers will be recommended to the full Board of Trustees at the Reorganization Meeting scheduled for December 6, 2016. In addition, Chairman Wise will announce at the Annual Reorganization meeting the trustee appointments to the Foundation Board of Directors.

As required by the State of New Jersey, Trustee Hirsch reported that the Committee reviewed the Campus Safety Report for the period September 19 through October 17, 2016.
