II. Catalog Description

This course continues with the study of the traditions of Western theatre from the beginning of the eighteenth century through contemporary times. The course will emphasize the theatre's historical, stylistic and cultural perspectives, with emphasis on what significant developments led to the genres of the modern theatre. Students may be required to attend a live performance.

III. Statement of Course Need:

- A. Theatre History is a core requirement in most theatre programs. The majority of four year schools require theatre majors to take two semesters of theatre history.
- B. This course generally transfers as an equivalent Theatre History course, or as a General Education, Arts or free elective.

IV. Place of Course in College Curriculum

- A. Free elective
- B. This course serves as a General Education elective in

Humanities/Appreciation of the Arts

- C. This course is a core program requirement for the A.A. Liberal Arts (Theatre Arts option).

V. Outline of Course Content

- A. Review of Restoration period.
- B. Introduction to Nineteenth Century Drama:

Romanticism, Melodrama, and the Well-Made Play. Students will read and discuss a play such as *Woyzeck* (Buchner).

C. Ibsen, Strindberg, and Realism:

The class will read and discuss plays by the prominent realist playwrights Henrik Ibsen and August Strindberg. Plays such as *A Doll's House* and *Miss Julie* will be read and discussed.

D. Chekhov and the Moscow Art Theater:

The class will read and discuss plays written by Chekhov such as *The Sea Gull* and *The Cherry Orchard*. The class will also read about and discuss Constantine Stanislavski and realistic acting.

E. Epic Theatre:

The class will read and discuss plays such as Galileo by Bertolt Brecht.

F. The American Scene:

The class will read and discuss plays such as *Anna Christie* (O'Neill), *A Streetcar Named Desire* (Williams), and *Death of a Salesman* (Miller). The Group Theatre and The Actors Studio will also be covered.

G. The Theatre of the Absurd:

The class will read plays such as *Waiting for Godot* (Beckett) or *The Dumbwaiter* (Pinter).

- H. Theatre of the 1960's and 1970's in both Europe and the United States.
- I. Theatre today:

The class may read plays by Shepard, Wilson, Albee, Norman, Vogel or Mamet.

X. Honors Options

<u>Definition</u>: According to the Honors Council, an Honors course is one that enriches and challenges students beyond a course's regular scope and curriculum. 3. Honors Option Content

Students who participate in the Theatre 108 Honors Option must complete 2 additional assignments.

- A. A fifteen minute presentation discussing an additional writer from one of the periods/genres discussed in the class.
- B. A three-page critique of a historically appropriate play at a professional regional or Broadway Theatre.

4. Assessment Instruments for Honors Option Work

Honors Option students will be assessed for their ability to deliver the additional required assignments. In particular they must:

- A. Demonstrate understanding of the writers, genres and styles of the period.
- B. Classify the dialogue of a play to the appropriate playwright.

5. Grade Determinants for Honors Option Work

- A. Research Paper
- B. Presentation of work to class
